

**Calvary Chapel of the Finger Lakes, Inc.**  
**Application for New FM Translator Station -- Cortland**  
**Facility ID 151672 -- Channel 296**  
**April 2013 -- Exhibit 1 -- LPFM Preclusion Study**

NAD 27 coordinates of the proposed Channel 296 Cortland, NY translator site are 42-37-30 N, 76-12-41 W. This site is located within the Town of Cortlandville in Cortland County, NY, which is not part of any metro radio market recognized by Arbitron; however, the site falls with the 39 kilometer LPFM Grid buffer zone for Syracuse, NY, a "spectrum-limited Appendix A Market".

The proposed effective radiated power of this facility is 0.027 kW at 27 meters height above average terrain. Based on use of the directional antenna specified in this application, the maximum predicted 60 dBu contour distance is 6.67 kilometers at a bearing of 212 degrees true. Therefore; when applying the LPFM distance separation requirements of 47 CFR 73.807(c), this translator should be categorized as having a 60 dBu contour distance of 7.3 km or less.

This study has been performed to determine the potential impact this translator would have on LPFM channel availability within the 20 x 20 minute Syracuse grid on Channels 294 to 298. The following channel-point data were determined using "LPFM Grid Tool" software provided by the FCC:

## Channel 298 Protection

The closest identified point within the Syracuse LPFM Grid where Channel 298 would be available is Point 421 at 42-52-53 N, 076-18-52 W. Spacing from the proposed translator site to this point is 29.70 kilometers, which exceeds the required second-adjacent LPFM separation of 8 kilometers

Please note that channels within the range 294 to 297 are not available for LPFM use within the Syracuse grid due to the licensed operation of WSYR-FM, Solvay, NY on Channel 295B1 and WKVU, Utica, NY on Channel 297B. Therefore, the instant translator application does not preclude any identified channel/point licensing opportunity within the Syracuse, NY grid for a future LPFM station.
