


Community Coverage Compliance with Section 73.315


The proposed minor change to KVLR specifies a move to a new site and an upgrade from Class A to Class C3. The proposed 3.16 mV/m contour will cover the community of license of Sunset Valley, TX with the exception of the area as indicated on the map on page 2 of this exhibit which represents less than 0.05% of the total Sunset Valley community area. As is indicated on the map on page 3 of this exhibit, a theoretical allotment site has been identified that will provide 3.16 mV/m coverage over the entire community of Sunset Valley. The theoretical allotment site is located 153 meters from the proposed site and is fully spaced to other broadcast facilities in accordance with Section 73.207 (reference page 5 of this exhibit). Based on this, the proposed minor change application of KVLR is in compliance with the community coverage requirements of Section 73.315.

Overview of 3.16 mV/m coverage




Community Coverage Compliance with Section 73.315

The community of license of Sunset Valley is outlined below in yellow. The proposed 3.16 mV/m contour covers Sunset Valley with the exception of the small uninhabited corner on the western edge of the city boundary as is indicated on the below map. This area represents less than 0.05% of the total area of the Sunset Valley community.




Community Coverage Compliance with Section 73.315
