The Drive LLC is the licensee of KHDR(FM), Lenwood, California (Facility ID No. 89344) and KHRQ(FM), Baker, California (Facility ID. No. 89128) (the “Stations”).

By this application, The Drive LLC seeks Commission consent to the transfer of the 30.3 percent membership interest in The Drive LLC currently held by Highway Radio, Inc. from Highway Radio, Inc. to KHWY, Inc. 1/ As a result of this proposed transfer, KHWY, Inc. will increase its membership interest in The Drive LLC from 18.7 percent to 49.0 percent.

Additionally, The Drive LLC seeks Commission consent to the transfer of the 0.5 percent membership interest in The Drive LLC currently held by Todd P. Robinson d/b/a ReKab Broadcasting from Mr. Robinson to Point Broadcasting Company (“Point”). As a result of this proposed transfer, Point will increase its membership interest in The Drive LLC from 31.8 percent to 32.3 percent.

This application is being filed on FCC Form 315 because the proposed transaction, in combination with the recently consummated *pro forma* assignment of the Stations to The Drive LLC, will constitute a cumulative transfer of more than a 50 percent interest in the licensee the Stations. 2/

1/ Highway Radio, Inc. is merging with and into KHWY, Inc., as part of a stock exchange transaction.
