

**Other Authorizations**

This application seeks the Commission's consent to assign KDLH(TV), Duluth, Minnesota (Fac. ID 4691) to SagamoreHill of Duluth Licenses, LLC ("SHD Licenses, LLC").<sup>1</sup> SagamoreHill Midwest, LLC ("Midwest"), the parent company of SHD Licenses, LLC, is also the parent company of the licensees of KZTV(TV), Corpus Christi, Texas (Fac. ID 33079) and KXLT-TV, Rochester, Minn. (Fac. ID 35906). Louis Wall owns a full 100 percent interest in Midwest and is the company's President and CEO. Mr. Wall is also President of SagamoreHill Broadcasting, LLC ("SHB LLC"), the parent of the licensees of WLTZ(TV), Columbus, Ga. (Fac. ID 37179) and WNCN(TV), Montgomery, Ala. (Fac. ID 72307).<sup>2</sup>

Mr. Wall is a lifelong broadcaster who has worked in the television industry since 1974, where he started in sales and, by 1990, worked his way up to General Manager. Under Mr. Wall's guidance as GM, WBTW, Florence, S.C. (Fac. ID 66407) won South Carolina's Station of the Year in 1992, and WJBF, Augusta, Ga. (Fac. ID 27140) was awarded Georgia Station of the Year four times between 1993 and 2000. In 2000, Benedek Broadcasting hired Mr. Wall as Group Head with responsibility for ten stations.

In 2003, Wall founded SagamoreHill Broadcasting, a station group which has demonstrated his dedication to improve the stations' commitments to their respective communities. For instance, KGWN-TV began Northern Colorado 5, a CBS station that served Northern Colorado with news, weather, and a full complement of CBS programming where there had been little dedicated local programming before. In Laredo, Texas, a 94% Hispanic Market, KGNS-TV added Telemundo to the digital tier of service and is now one of the top performing stations in the market. And whereas WLTZ(TV) in Columbus, Ga. had no local news and little involvement in its community before its purchase in 2007, the station now airs news four hours per day, including an unprecedented major commitment to the Alabama side of the market. Mr. Wall subsequently formed Midwest and extended his commitment to broadcast television.

ID 63166), KSTF(TV), Scottsbluff, Neb. (Fac. ID 63182), KGNS-TV, Laredo, Texas (Fac. ID 10061), and WWMB(TV), Florence, S.C. (Fac. ID 3133). See, e.g., CDBS File No. BOA-20131218FAO. Louis Wall and Debra K. Caine have attributable interests in Midwest, SHCC LLC, and SHCC Licenses LLC.
