

EXHIBIT 10
Changes in Interests

As described in Exhibit 2 hereto, Backyard Broadcasting Holdings, LLC (“Backyard Holdings”) is a parent company of the licensee. No changes are proposed to the direct ownership of the licensee itself. The only change proposed is the expansion of the five-member Board of Representatives of Backyard Holdings by one member, which member shall be appointed by PCG Media Investment Partners, LLC (“PCG”), a previously insulated Class C member of Backyard Holdings. PCG acquired an insulated minority membership interest in Backyard Holdings on December 30, 2003.

¹Class B Units have no voting rights with respect to the management, governance, or control of Backyard Holdings and the Class B capital contributions comprise less than 0.01% of the total assets of Backyard Holdings. Class B Units represent the right to receive a portion of the distributions made to members after Class A members have received specified returns on their investments. Backyard Holdings has issued 600 Class B Units to Mr. Drake, 200 Class B Units to Ms. Smith, and 50 Class B Units to Mr. Atkins.

²Backyard Broadcasting Management, LLC appoints 4 members of the Board of Representatives. The current Backyard Broadcasting Management, LLC appointees are Barry Drake, Barry Baker, Barbara M. Ginader, and Roy F. Coppedge III.

³Boston Ventures Limited Partnership VI (“BVLPI”) appoints 1 member of the Board of Representatives. The current BVLPI appointee is Neil A. Wallack.

⁴Upon the consummation of the transaction pursuant to Commission approval, PCG’s membership interest will no longer be an “insulated” interest and PCG will appoint one (1) member to the Board of Representatives. PCG’s proposed appointee is Monte Brem.

⁵The parties contemplate subsequent investment that may increase the equity interest of PCG to 33%.
