

## **Wachovia Capital Partners 2002, LLC**

### **Other Media Interests**

Wachovia Capital Partners 2002, LLC (“WCP LLC”) is ultimately controlled by Wachovia Corporation (“Wachovia”). Wachovia is also the ultimate corporate parent of Wachovia Capital Investments, Inc. (“WCI”) and Wachovia Capital Partners, Inc. (“WCP, Inc.”). WCI holds 4.21% voting interest in the Class A units of GOCOM Holdings, LLC (“GOCOM Holdings”). WCP, Inc. is an attributable member of and holds a 20.22% voting interest in the Class A units and a 2.22% non-voting interest in the Class B and D units of GOCOM Holdings. As such, it is entitled to appoint two members to the Board of Representatives of GOCOM Holdings. L. Watts Hamrick, III and Michael Gray are members of the Board of Representatives of GOCOM Holdings as appointed by Wachovia Capital Partners, Inc.

GOCOM Holdings wholly owns the entities listed below, each of which is the sole member of the licensee of the television station(s) indicated below:

- GOCOM Broadcasting of Anchorage, LLC, which is the sole member of GOCOM of Anchorage License Sub, LLC, licensee of KTBV (TV), Facility ID 35654, Anchorage, Alaska.
- GOCOM Broadcasting of Joplin, LLC, which is the sole member of GOCOM of Joplin License Sub, LLC, licensee of KODE-TV, Facility ID 18283, Joplin, Missouri.
- GOCOM Broadcasting of Savannah, LLC, which is the sole member of GOCOM of Savannah License Sub, LLC, licensee of WJCL-TV, Facility ID 37174, Savannah, Georgia.
- GOCOM Broadcasting of Huntsville, LLC, which is the sole member of GOCOM of Huntsville License Sub, LLC, licensee of WAAY-TV, Facility ID 57292, Huntsville, Alabama.

- GOCOM Television, L.L.C., which is the sole member of GOCOM License, L.L.C., licensee of WFXI (TV), Facility ID 37982, Morehead City, North Carolina and WYDO (TV), Facility ID 35582, Greenville, North Carolina.
- GOCOM Television of Macon, L.L.C., which is the sole member of GOCOM-Macon License, L.L.C., licensee of WGXA (TV), Facility ID 58262, Macon, Georgia.
- GOCOM Television of Ouachita, L.L.C., which is the sole member of GOCOM-Ouachita License, L.L.C., licensee of KTVE (TV), Facility ID 35692, El Dorado, Arkansas.

#### Disclosure Regarding Non-Exempt Officers and Directors

Responsibility for WCP LLC's proposed acquisition, voting and disposition of the interests in Three Eagles Communications (the "Investment") lies with WCP LLC. Wachovia Investors, Inc. ("WI, Inc."), which is a member of WCP LLC, and Wachovia, which as noted above is WCP LLC's ultimate corporate parent, are reported in as attributable parties to the application in connection with WCP LLC as a transferee. However, the consent of neither WI, Inc. nor Wachovia was required for WCP LLC to make the Investment, and neither WI, Inc. nor Wachovia had or has any involvement with the acquisition, voting or disposition of the Investment interest.

The officers and directors of Wachovia and WI, Inc., except for certain of those listed in Exhibit 14b, have duties and responsibilities wholly unrelated to the media business of WCP LLC. WCP LLC has reported information for all officers of Wachovia and WI, Inc. who may be regarded as being in the reporting chain from WCP LLC through to Wachovia. WCP LLC also is reporting information for each of the directors of those same Entities together with the other media interests of the non-exempt officers and directors. This approach is consistent with the Commission's policies for the reporting of officer and director interests for multi-faceted financial entities. *See WTVY-TV, Dalton, Alabama*, Letter of Barbara Kreisman, Chief, Video Services Division, dated March 16, 1993 (Ref. 1800E1-AEG).
