FM OVERLAP REQUIREMENTS

This application proposes a new location for licensed translator K280BZ, Wenatchee, WA. The new location is on an existing tower one-second south and one-second east of the current location. The antenna height would be increased 8 meters AMSL. The ERP would be reduced from 54 to 50 watts.

K280BZ is a grandfathered pre-1991 translator, covered by the provisions of 74.1235(j). As such, the ERP limitations of 74.1235(b) do not apply.

With the power reduction outlined above, the coverage contours at the new location would essentially be identical to those of the existing license. On the attached maps, the various interfering contours of the proposed translator are color coded, with the corresponding protected contours of other stations color-coded to match. As shown by **Exhibit 12a**, contour protection would be provided to all existing and proposed facilities, except K280BI, Ephrata, WA. **Exhibit 12b** shows that the area of overlap with K280BI would be reduced with this proposal. There is massive terrain blockage between the two translators. No objectionable interference is now occurring, and none is anticipated.

The 34dbu interfering contour does not cross the Canadian border, so no Canadian processing will be required.




Exhibit 12b - Prop. vs K280BI
