De Minimis Interference Evaluation of proposed facility for WIWB-DT DTV Channel 21 Suring, WI July 30, 2001

WIWB-DT channel 21 Suring, WI has previously proposed to relocate its FCC allotted DTV facility to a tower that will be located at 44-20-02 North Latitude and 87-58-57 West Longitude (FCC reference number BPCDT-19991101AHT). Because of difficulty in obtaining authorization to build a tower with the originally specified height, a shorter tower has now been specified and approved. Since the elevation has been changed it was necessary to adjust the ERP and antenna pattern to compensate for the height reduction. Since the proposed elevation, site location and power do not meet the "checklist" criteria a new de minimis interference analysis was required. It is also noted that the coordinates of the site have also been slightly adjusted to 44-20-01 North Latitude and 87-58-56 West Longitude

The de minimis interference analysis was performed in accordance with Appendix B of the FCC Sixth Report and Order in MM Docket No. 87-268 and FCC OET Bulletin No. 69. The software used to perform the analysis is the same as that being used by the FCC for application processing and therefore should yield the same results. The results of that analysis indicate the proposed facility meets the FCC's de minimis interference criteria toward all other DTV allotments as well as all authorized DTV and analog stations
