Dear Ms. Dortch:

On behalf of Unalaska Community Broadcasting, Inc., ("UCB"), licensee of deleted LPTV Station DK08IW, Dutch Harbor, Alaska, we hereby request special temporary authority for operation of the station pending action on a Petition for Reconsideration of the deletion of the station from the Commission's database and a late-filed application for renewal of license, both filed today with the Commission. The name of the licensee was changed from Unalaska Community Television, Incorporated to Unalaska Community Broadcasting, Inc. in February 1996, but there was no change in ownership associated with that name change.

As stated in the Petition for Reconsideration, this nonprofit station serves Dutch Harbor and Unalaska, Alaska and the surrounding area of the Aleutian Islands. This location is where the Bering Sea meets the Pacific Ocean, at the terminus of the Alaska Marine Highway. The community of license has no other local video service, and the service area is hundreds of miles from the nearest station that originates video programming. This station is a key community resource in a remote area of Alaska, serving an ethnically and culturally diverse population. Dutch Harbor is known as America's richest fishing port, with many people performing very dangerous work. It is subject to storms that can last a week, with seas ranging up to 50 feet and frequent storms with hurricane force winds during the winter. All means of communications are involved at times in public safety broadcasting.

The licensee inadvertently failed to file for renewal during the last application period. The license was deleted from the Commission's database on October 15, 2004, and the licensee has petitioned for reconsideration and filed an application for renewal. The station has had managers only intermittently, but the board of directors has now hired a manager who is aware of Commission procedures and deadlines. The licensee wishes to gain reinstatement and renewal of the license and submits that continued operation of the station would clearly be in the public interest.

No fee is required for this filing, pursuant to Section 1.1114(e)(2), inasmuch as it pertains to an LPTV station that is operated by a nonprofit corporation on a noncommercial educational basis.

The licensee has authorized us to state on its behalf that neither it nor any party to this request is subject to denial of federal benefits under the Anti-Drug Abuse Act of 1988.


