

### **Exhibit 35 - - Request for Extension of Special Temporary Authority**

KM LPTV of Chicago-28, L.L.C. ("KM") is the licensee of Class A television station WOCH-CA, Chicago, Illinois (Facility ID No. 35101, "WOCH"). In January 2006, WOCH changed channels and is now licensed on Channel 41 (File No. BLTTA-20060103ACT), due to WOCH's displacement from its previous Channel 28 by the digital television ("DTV") transition. On September 25, 2006, KM was granted special temporary authority ("STA") to allow WOCH to restore off-the-air service and coverage lost upon its change in channel, in order to better serve its targeted ethnic and minority communities, that were within WOCH's former protected service area on Channel 28 but can no longer receive WOCH on Channel 41 over-the-air, see File No. BSTA-20060210ABD (the "STA"), which STA has been extended twice, most recently through September 25, 2008. See File Nos. BESTA-20070321ACO, BESTA-20070924AGB and BESTA-20080318ACA. The STA authorizes KM to operate WOCH with an Andrew ALP16M6-CSWX-41-CUSTOM directional antenna, with 150 kilowatts effective radiated power ("ERP") toward the radio horizon (and with 255 kilowatts ERP at angles below the horizon using beam tilt), from WOCH's licensed transmitter site on top of the John Hancock Center building in downtown Chicago.<sup>1</sup> WOCH began operating under the STA parameters on or about October 12, 2006.

Extension of the STA would serve the public interest by permitting WOCH's very loyal viewers to continue to receive the station over the air in the manner they have become accustomed to under the STA (now for almost two years, during which time KM has received no complaints of interference), and when WOCH previously operated on Channel 28. KM requests an extension of the current STA for six months, to March 25, 2009, or until the Commission acts on KM's pending minor change application proposing a similar directional antenna for WOCH on Channel 41 (File No. BPTTA-20050127ALO). The Commission has expressly recognized that displaced stations or stations facing "disruption of service" due to the DTV transition, such as WOCH in this case, are under extraordinary circumstances such that grant of an STA would be appropriate, to ensure that existing service to the public may be continued.

Therefore, since KM has demonstrated that restoration of WOCH's over-the-air service to its existing loyal viewers under the STA presents "extraordinary circumstances" which warranted the original grant of the current STA and its extension as requested herein, and that grant of the STA extension would serve the public interest, extension of the STA is respectfully requested.
