I. Description of *Pro Forma* Assignment

As the Commission is aware, the ultimate parent of FCC licensee Warwick Communications, Inc., White Knight Holdings, Inc. ("Parent"), became the subject of a Chapter 11 bankruptcy proceeding in June 2006. See FCC File No. BTCCT-20060711ABB.

In association with the above referenced bankruptcy proceeding, this application seeks consent of the Federal Communications Commission ("Commission") to the *pro forma* assignment of television station KFXK(TV), Longview, Texas, television translator stations KFXL-LP, Lufkin, Texas, KLPN-LP, Longview, Texas and KTPN-LP, Tyler, Texas from Warwick Communications, Inc. ("Licensee") to Warwick Communications, Inc., Debtor-in-Possession.

On July 11, 2007, Licensee submitted a voluntary petition ("Petition") for bankruptcy to the United States Bankruptcy Court for the Western District of Louisiana ("Bankruptcy Court") seeking to reorganize under Chapter 11 of the U.S. Bankruptcy Code. The Petition, a copy of which is attached hereto, seeks bankruptcy protection for Licensee.

The proposed *pro forma* assignment does not effect a substantial change in the control of Licensee, as the officers, directors, and shareholders of Licensee remain unchanged following the filing of the Petition. Mr. Sheldon H. Galloway will continue to control Licensee, as a debtor-in-possession, subject to the jurisdiction and oversight of the Bankruptcy Court.
