Dear Mr. Chambers:

This is in reference to the request filed October 29, 2007, on behalf of Radio Dalhart ("RD"). RD requests extension of the special temporary authority ("STA") granted on April 18, 2007, to operate Station KIXK (formerly, KXIT-FM) with emergency antenna facilities pursuant to Section 73.1680.¹ In support of the request, RD states that, following storm damage to the licensed tower, it continues the process of evaluating what will be done to make repairs.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Our review indicates that Application BMPH-20080408AEX remains pending before the Commission; thus, the licensee has been prevented from restoring licensed operation due to causes beyond its control and has taken all possible steps to expeditiously resolve the problem. Consequently, extension of STA is warranted.

Accordingly, the request for extension of STA IS HEREBY GRANTED. Station KIXK may

¹ KIXK is licensed for operation on Channel 242C1 (96.3 MHz) with effective radiated power of 100 kilowatts (H&V) and antenna height above average terrain of 144 meters.


continue to operate from its licensed site with the following facilities:

Channel	242 (96.3 MHz)
Effective radiated power:	15 kilowatts (H&V)
Antenna height:	
above ground:	100 meters
above mean sea level:	1292 meters
Above average terrain:	110 meters

RD must notify the Commission when licensed operation is restored. RD must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on **October 29, 2008**.
