
Greetings.

Attached on behalf of our client, Canfin Enterprises, Inc., the licensee of AM Broadcast Station KWKC, Abilene, Texas, please find an original and two copies of an application on FCC Form 302-AM requesting a return to Direct Measurement of Power. This application is being filed directly without a fee inasmuch as it seeks only Direct Measurement of Power.

The application is filed pursuant to Special Condition #4 of the above-referenced construction permit, which permitted the mounting of an antenna on the non-directional tower of KWKC, to accommodate FM Broadcast Station KKHR, Abilene, TX, also licensed to Canfin Enterprises, Inc. During construction of that antenna on the KWKC tower, KWKC was required to determine operating power by the indirect method. Condition #4 of the construction permit called for impedance measurements on the AM antenna and an application for KWKC to return to direct power measurement, together with a tower sketch. This is that application.



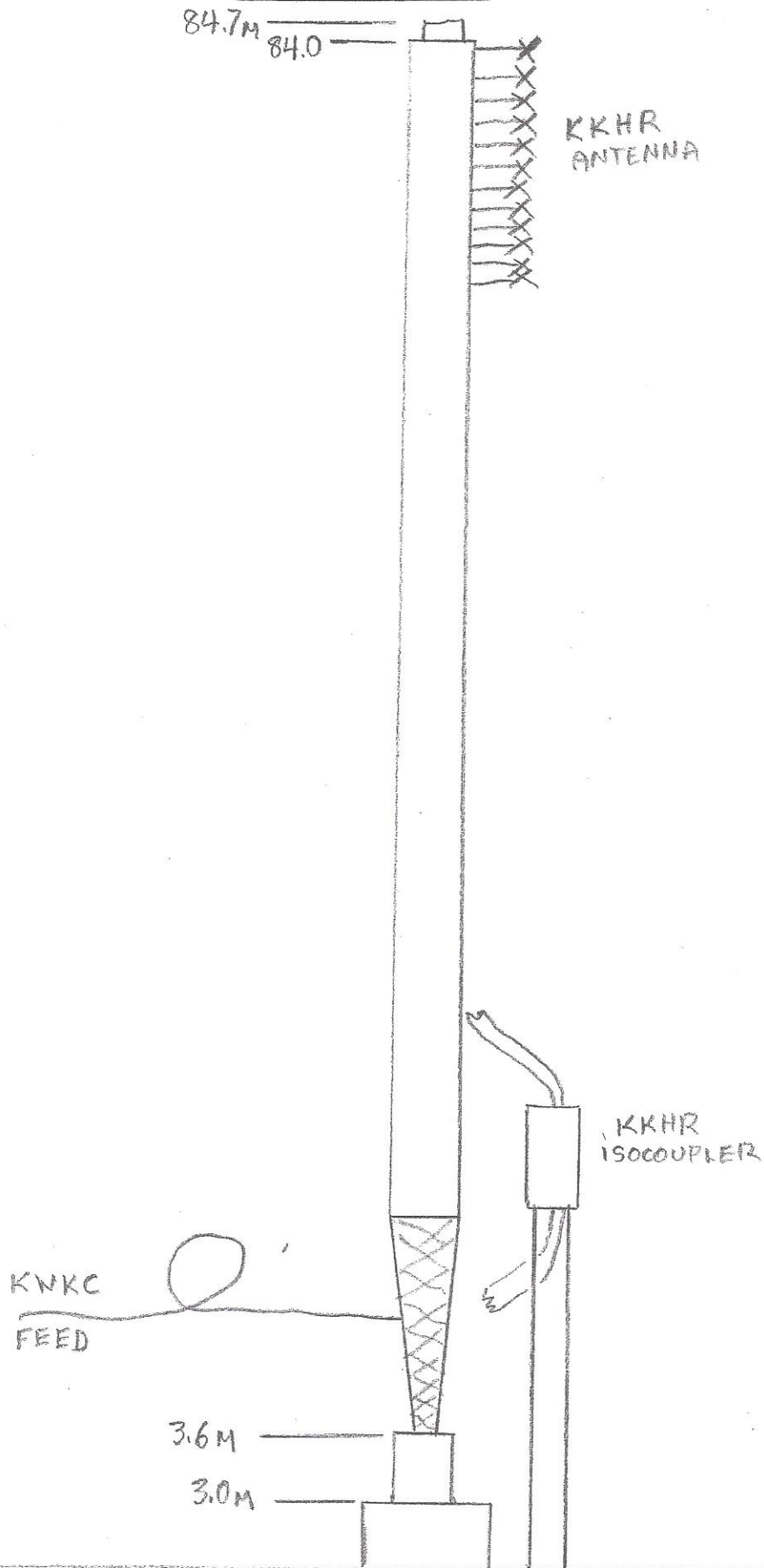
