WSHU(AM) Narrative

SACRED HEART UNIVERSITY, INCORPORATED ("SHU"), RESPECTFULLY REQUESTS A FURTHER EXTENSION OF ITS SPECIAL TEMPORARY AUTHORIZATION ("STA") TO OPERATE WSHU(AM) WITH TEMPORARY FACILITIES, USING THE FRONTIER TELEPHONE COMPANY TOWER AS A SUPPORT FOR A TEMPORARY SLOPING DIPOLE ANTENNA.

SHU FILED AN APPLICATION FOR A PERMANENT SITE IN SEYMOUR, CONNECTICUT, WHICH WAS GRANTED BY THE FCC. SEE BPH-20140821AFR. AFTER THE ADOPTION OF THE FIRST REPORT AND ORDER, FURTHER NOTICE OF PROPOSED RULE MAKING, AND NOTICE OF INQUIRY IN THE MATTER OF AM REVITALIZATION OF THE AM RADIO SERVICE, SHU AND ITS ENGINEERS RE-EVALUATED THE ANTICIPATED MOVE TO SEYMOUR. RELAXATION OF THE COMMUNITY COVERAGE REQUIREMENTS CAUSED SHU AND ITS ENGINEERS TO DISCUSS THE POSSIBILITY OF MAKING THE CURRENT, TEMPORARY TRANSMITTER SITE IN WESTPORT, CONNECTICUT PERMANENT, GIVEN ITS PREFERABLE LOCATION. FURTHER TECHNICAL ANALYSIS REVEALED THAT, BECAUSE THE FCC HAD NOT CHANGED THE ALLOCATION RULES YET, SHU WOULD BE FORCED TO DECREASE THE POWER OF WSHU FROM 1 KW TO 175 WATTS OMNI, WHICH WOULD NOT BE IN THE BEST INTEREST OF THE PUBLIC OR SHU.

NOW THAT THE FCC HAS ADVISED SHU THAT THE ALLOCATION SITUATION IS NOT LIKELY TO CHANGE AND SHU MUST LOOK TO AN ALTERNATIVE LICENSABLE FACILITY, IT IS CLEAR THAT REDUCED POWER OPERATION CAN NOT BE AVOIDED. SHU AND ITS ENGINEERING FIRM HAVE BEEN TESTING DIFFERENT METHODS OF FEEDING THE TOWER AT THE STA SITE, USING METHOD OF MOMENTS, AND BELIEVE THAT AN INTERNAL FEED SYSTEM WILL MEET FCC FILING REQUIREMENTS. SHU PLANS TO IMPLEMENT THAT SYSTEM AND, IF IT PERFORMS AS ANTICIPATED, IT WILL BE FORMALIZED AS PART OF A 301 APPLICATION FOR CONSTRUCTION PERMIT WHICH SHU EXPECTS TO FILE AS SOON AS POSSIBLE.

SINCE THE SUBMISSION OF THE LAST REQUEST TO EXTEND THE STA, FIRST, SHU WAS DELAYED IN TESTING THE NEW ANTENNA BECAUSE AN OSPREY BIRD NEST WAS FOUND ON THE TOWER. THEN, CONSTRUCTION PROJECTS IN THE SURROUNDING AREA DELAYED TESTING BECAUSE THERE WAS NO ACCESS TO THE TOWER SITE. A TEMPORARY ROAD TO THE SITE HAS NOW BEEN COMPLETED AND THE FEDERAL PROTECTION REQUIREMENTS HAVE ALSO BEEN RESOLVED. SHU HAS SCHEDULED A RIGGING CREW TO RECONFIGURE THE ANTENNA WHICH WILL THEN UNDERGO TESTING. HOPEFULLY A NEW FORM 301 CAN BE FILED IN THE NEAR FUTURE.

ACCORDINGLY, SHU RESPECTFULLY REQUESTS A FURTHER EXTENSION OF THE WSHU STA UNTIL THE FORM 301 APPLICATION IS FILED AND GRANTED.
