

**EXHIBIT 12**

The KBOO Foundation (“KBOO”), licensee of Noncommercial Educational Station KBOO (FM-NCE), Portland, Oregon, and permittee of KBLU-FM (NCE), Pilot Rock, Oregon, is a non-stock, non-profit organization. KBOO is filing this application to obtain Commission consent to new members of its Board of Directors.

The selection of KBOO’s new Board of Directors took place pursuant to its Articles of Incorporation and By-Laws. The resulting transfer of control occurred gradually, over time, through routine changes in board membership at annual elections, and by interim appointments to fill board vacancies.

This application is intended to bring the stations into compliance with the requirement to obtain FCC approval of the board after 50% of the members of the board of directors have changed. The FCC last approved the board of KBOO in January 15, 2009, in FCC File No. BTCED-20081103ACL.

No consideration or thing of value is being given in exchange for the interests being transferred. All except one of the Board Members are U.S. citizens. Each Board Member has one vote. None have any interests in any mass media other than KBOO’s stations.
