TECHNICAL STATEMENT

1. This technical statement and attached exhibits were prepared of behalf of Tama Radio Licenses of Jacksonville, FL, Inc. ("Tama"), licensee of WJSJ, Channel 287A, Fernandina Beach, Florida; WSJF, Channel 288C3, St. Augustine Beach, Florida; and WHJX, Channel 289C3, Baldwin, Florida. Tama is submitting minor change applications for all three stations, therefore a Radio Market Analysis is needed. WJSJ, WSJF and WHJX are each licensed to a community within a metro county in the Jacksonville, Florida Arbitron market (Market #48).¹ Since the three FM stations are located in the same Arbitron market, an analysis based on the stations in a rated market is necessary.

2. As shown on Exhibit #1, there are forty-five AM and FM (commercial and non-commercial) stations listed in the Jacksonville, Florida Arbitron Market. Tama would remain in control of three FM stations in the market. The number of stations indicated falls in the forty-five or more stations tier of §73.3555(a)(1)(i) of the Commission's rules. At this level, common ownership or control of up to eight stations, with no more than five in the same service, is permissible. Therefore, the minor change applications for WJSJ, WSJF and WHJX are believed to be in compliance with the Commission's radio ownership rules for rated markets.

1) WJSJ is changing its community of license to Yulee, Florida. Yulee, Florida is located within Nassau County, a metro county within the Jacksonville, Florida market.
