
Dear Madam Secretary:

This will notify the FCC concerning the status of the station WBBT(AM) online Public Inspection File.

During the above-captioned station's current license term, the radio station broadcast public interest programming and prepared Issues and Programs Lists for the station's Public Inspection File on a timely basis. However, when transitioning those same lists to the newly established online Public Inspection File hosted on the FCC website, the licensee's personnel was not aware that Issues and Programs Lists for the entire current license term must be uploaded to the online Public Inspection File, rather than only those lists created after the March 1, 2018, initial online PIF compliance deadline. The licensee regrets these instances and takes its obligations seriously. The licensee has reviewed the Issues and Programs List requirements with its station staff and emphasized its importance to ensure compliance. The licensee has implemented steps, including additional employee training and supervision, to avoid recurrence.
