
This is in reference to: (1) the above captioned application, as last amended on May 6, 2010, for WKJV-LP, Bristol, VA and (2) the July 30, 2009 Informal Objection filed by Bristol Broadcasting Company, Inc. ("Bristol"), licensee of WFHG-FM, Abingdon, VA.

On April 22, 2008, the staff informed BMBC that as a result of the grant of modification for WFYE(FM), Glades Spring, VA, WKJV-LP would be displaced.¹ On July 22, 2009, BMBC filed a minor change application (BPL-20090722ABL) proposing to operate on Channel 226 and create a second-adjacent channel short-spacing to WFHG-FM, pursuant to the second adjacent channel waiver procedures adopted by the Commission in its Third Report and Order in *Creation of a Low Power Radio Service*.²

On July 30, 2009, Bristol filed an informal objection stating that BMBC's application, as originally filed, would create a first-adjacent channel short-spacing to WFHG-FM's modification (BPH-20090729AEG) and this would cause interference within WFHG-FM's 70 dBu contour. BMBC addressed Bristol's concerns in its May 6, 2010 amendment by proposing a different channel and site location. Furthermore, an engineering review of the BMBC application, as last amended, demonstrates compliance with all necessary rules. Accordingly, the July 30, 2009 Informal Objection filed Bristol will be dismissed as moot and BMBC's application will be granted.

In light of the above, the Informal Objection filed by Bristol on July 30, 2009 IS HEREBY DISMISSED AS MOOT. In addition, Application File No. BPL-20090722ABL, as last amended on May 6, 2010, IS HEREBY GRANTED.
