

ENGINEERING STATEMENT  
RADIO MULTIPLE OWNERSHIP ANALYSIS

This radio multiple ownership analysis was prepared on behalf of Debut Broadcasting Mississippi, Inc. to consider the acquisition of FM station WBBV(FM) at Vicksburg, Mississippi, and an LMA with KLSM(FM) at Tallulah, Louisiana. The stations were considered under the FCC “Interim” contour analysis method, as the stations are located outside of any Arbitron market.\* Below is a tabulation of facilities for each station.

The principal community contours of these stations are depicted on a map included herein as Figure 1. Since the principal community contour (3.16 mV/m for FM stations) of the KLSM(FM) licensed or authorized construction permit facility is involved in overlap with WBBV(FM)’s principal community contour, an ownership study was prepared in accordance with the Federal Communications Commission multiple ownership rules as outlined in Section 73.3555.

#### Radio Market

The “radio market” applicable to common ownership of the subject stations are defined as the area encompassed by the mutually overlapping principal community contours of the stations proposed to be commonly owned. Please note that in this situation Debut is, as noted above, acquiring only one of the stations WBBV and has an LMA for the other station KLSM, said LMA being an attributable interest under the Commission's Rules. There is one new “radio market” to consider. The table below lists the defined market:


### Count of Stations in the Defined Market

The number of radio stations in a “radio market” is determined by counting the operating stations having principal community contours that overlap or intersect the principal community contours, which define the radio market. Only those stations located within 92 km of the perimeter of the mutual overlap area of the defined market area were employed in the count of stations. The results of the analysis are tabulated below:

Figure 2 is a tabulation of other stations in the defined market. Only known licensed, operating stations were employed for the study. It is noted that there are 20 total stations in the defined market regardless of which KLSM(FM) facility is considered. Distances to the AM coverage contours were predicted using the antenna patterns as identified in the Commission’s AM database and the appropriate Ground Wave Field Strength versus Distance Graph of 47 CFR 73.184. Ground conductivity data were obtained from FCC Figure M3. Distances to the FM contours were determined based on the method of 47 CFR 73.313. Terrain data was derived from the USGS 3-second computer database for each of the FM stations using radials evenly-spaced every 10 degrees of azimuth.

Based on the above, the acquisition of FM station WBBV(FM) at Vicksburg, Mississippi and LMA of station KLSM(FM) at Tallulah, Louisiana complies with Section 73.3555(a) of the FCC Rules.

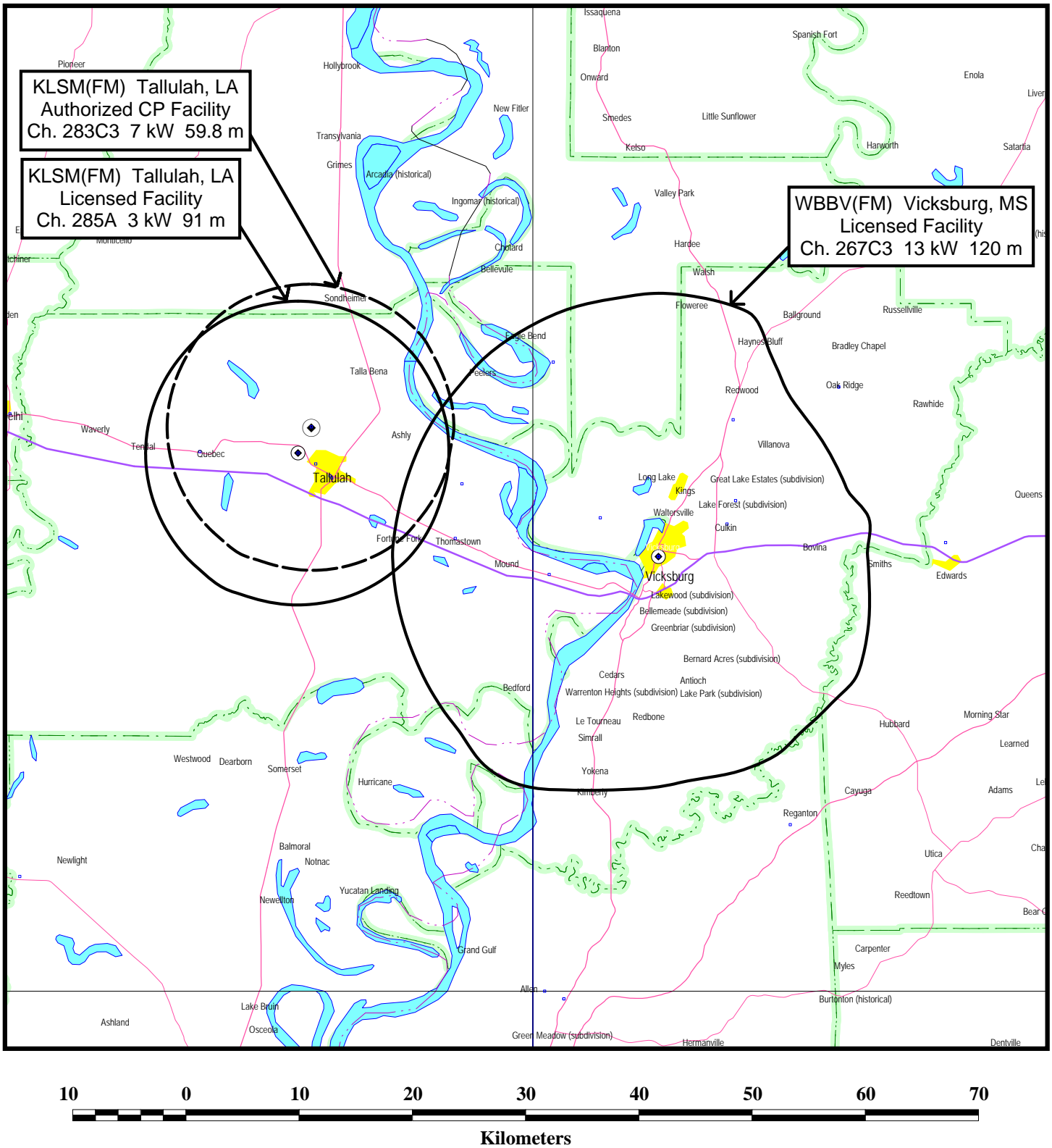
