GE is a publicly-traded company in which no director or officer has an attributable interest through any means other than by virtue of his or her position.

No other party is known to hold an attributable interest in any of these companies solely by virtue of their voting stock or total asset holdings. Other than the GE directors noted, no other officer or director of any of these entities has an attributable interest in any other regulated media entity.
