Munbilla Broadcasting Properties, Ltd. (*MBPL*) is the winning bidder in Auction No. 62 for Channel 259A at Mason, Texas. Accordingly, MBPL is submitting the instant application to obtain a construction permit for the Mason allotment.

MBPL is providing the following information in response to FCC Form 301, Section II, Item 10.

- **Section 1.2107(d): Bidding Consortia or Joint Bidding Arrangements.** MBPL has not entered into any partnership, joint venture, consortium, or other agreement, arrangement, or understanding of any kind relating to the subject allotment or the applied-for authorization, including any agreement relating to the post-auction market structure.
- **Section 1.2110(i): Bidding Credit Eligibility.** As Exhibit 3 shows, MBPL is the licensee of several other broadcast stations. Accordingly, MBPL did not claim entitlement to any bidding credit.
- **Section 1.2112(a) and (b): Ownership and Real Party in Interest.** MBPL is a limited partnership organized under the laws of the State of Texas. MBPL is the real party in interest in the instant application.

As MBPL's response to Section II, Item 2(a) indicates, MBPL has one General Partner, and one Limited Partner.

MTLL is a Texas Limited Partnership engaged in the acquisition and construction of communications sites and towers and engages in the leasing thereof. In connection with such business operations, MTLL holds certain FCC Tower Registrations.

Mr. Fox is the President and Manager of MTLL. MBSL is the Sole General Partner of MTLL, and MDHL is the sole Limited Partner of MTLL. MBSL's and MDHL's degrees of equity holding in and exercise of voting control over MTLL are the same as disclosed above with respect to MBPL.

None of these entities, nor Mr. Fox nor Mr. Kilby personally:
