**Section 73.5005(a) Certification**

The applicant certifies, pursuant to 47 C.F.R. Section 73.5005(a), that the exhibits to this application contain all of the information required by 47 C.F.R. Sections 1.2107(d), 1.2110(i), 1.2112(a) and 1.2112(b), if applicable. All such information is provided below or included in other exhibits to this application.

**Agreements with Other Parties and Joint Bidding Arrangements**

Prior to the time bidding in Auction 37 was completed, College Creek Broadcasting, Inc. (“College Creek”) had agreements with certain other entities or individuals that related to the competitive bidding process. As required by Section 1.2107(d), these agreements are described below.

**College Creek Media, LLC** – College Creek has entered into an agreement with College Creek Media, LLC (“Media”) whereby Media provided financing for College Creek’s acquisition of construction permits in Auction 37 in the form of loans to College Creek evidenced by notes from College Creek to Media. Media has the option, but not the obligation, to acquire the construction permits acquired by College Creek in Auction 37 in exchange for the notes. In the event Media exercises its right to acquire the construction permits, College Creek shall be entitled to a fee in addition to its costs and expenses. In the event Media does not exercise its rights to acquire the construction permits, College Creek shall pay the notes in accordance with their terms. Media is owned and controlled by Media Focus, LLC, College Creek’s sole shareholder (see Exhibit 2).

**Davidson Media Group, LLC** – College Creek has entered into an agreement with Davidson Media Group, LLC whereby it has agreed to provide advisor, consulting and technical services to Davidson to assist Davidson in acquiring FM broadcasting facilities in certain markets. There exists no joint ownership or partnership relationship among these entities nor are they under common control. Certain construction permits allocations available in Auction 37 might have satisfied the conditions of College Creek’s agreement with Davidson, and, as such, College Creek and Davidson discussed the bidding prices of these construction permit allocations during the auction. College Creek, however, was not the winning bidder with respect to any of these allocations. Although College Creek remains obligated to assist Davidson in acquiring FM broadcast facilities, College Creek’s obligations will not involve any construction permits obtained through Auction 37.

**Victor A. Michael** – College Creek assumed an agreement whereby Victor A. Michael provided College Creek with consulting and engineering services in connection with Auction 37. In particular, Mr. Michael provided an engineering analysis of each of the communities and frequencies associated with construction permit allotments. During Auction 37, College Creek and Mr. Michael had some communications regarding the bidding, specifically as to the value of certain construction permits allotments based on Mr. Michael’s engineering analysis of various factors involved in the construction of a station for each allotment. College Creek expects to continue to use Mr. Michael’s engineering services in the preparation of its long-form

applications. There exists no joint ownership or partnership relationship among these entities nor are they under common control.

With respect to Auction 37, other than as discussed above, neither College Creek nor any of its affiliated entities has entered into any partnerships, joint ventures, consortia or other agreements, arrangements or understandings of any kind relating to the licenses being auctioned, including any such agreements relating to post-auction market structure.
