BLUE LAKE RANCHERIA IS AN INDIAN TRIBE THAT HOLDS AN 21.7% INTEREST IN LOST COAST COMMUNICATIONS. EACH OF THE TRIBAL MEMBERS OWN EQUAL SHARES IN BLUE LAKE RANCHERIA, AND THEREFORE EACH TRIBAL MEMBER OWNS A LESS-THAN-10% INDIRECT INTEREST IN THE APPLICANT. THE TRIBE IS GOVERNED BY A FIVE-MEMBER BUSINESS COUNCIL, THE MEMBERS OF WHICH ARE IDENTIFIED AS INDIRECT OWNERS OF THE APPLICANT. ERIC RAMOS IS THE CEO OF THE TRIBE, AND IS IDENTIFIED AS AN INDIRECT OWNER OF THE APPLICANT.
