In evaluating the proposed relocation and change of coverage for W56CU/W24CP FID 70098, an outgoing interference study was executed at the new tower location, and an ERP of 50 kW. The stations listed in the table below showed possible interference. When these stations were evaluated for outgoing interference using the OET-69 Longley Rice methodology. There was zero percent interference present found in each case when rounded to the nearest whole percent.
