Dear Mr. Guel:

Verizon Wireless is prepared to begin transmitting on the 700 MHz frequencies (746-757 MHz and 776-787 MHz) for which it is now the exclusive primary licensee in the Lafayette, Indiana area. Verizon Wireless provided advance notification to Hispanic Christian Community Network, Inc. ("HCCN") of its planned commencement of operations in this market, and has been in contact with HCCN regarding HCCN's transition off of Channel 65.

HCCN operates this LPTV station under an FCC license with secondary status. As such, you may not cause interference to primary licensees of this spectrum. Your continued operations on Channel 65 are interfering with Verizon Wireless' ability to commence its use of this spectrum on a primary basis. Your continued operations will cause interference to Verizon Wireless' customers' mobile device receivers. Further, Verizon Wireless provided HCCN with ample notice regarding its planned operations in the market, and has already delayed its primary use of the 700 MHz spectrum in the Lafayette, Indiana area in order to provide HCCN an opportunity to relocate to another channel.



Further operation of these 700 MHz frequencies after this date will be referred to the FCC's Enforcement Bureau and Wireless Telecommunications Bureau for corrective action.
