As the expanded band facility for KSOS(AM), KXOL(AM) is exempt from the Commission's multiple ownership restrictions until April 27, 2006. *See Entercom Kansas City License, LLC*, 17 FCC Rcd 24197 (2002); *Review of the Technical Assignment Criteria for the AM Broadcast Service*, 6 FCC Rcd 6273 (1991), *recon. granted in part and denied in part*, 8 FCC Rcd 3250 (1993) (subsequent history omitted).

SMG is the sole general partner and owner of a 3.4% equity interest in Simmons Lone Star Media, Ltd. ("Lone Star").

II. Approved Sale

The Commission approved the assignment of the permit for KUTR(AM) FROM Simmons-SLC, LS, LLC to Bonneville Holding Company. *See* FCC File No. BAP-20021122ACC. The parties have not yet consummated the transaction.
