TECHNICAL STATEMENT

1. This technical statement and attached exhibits were prepared on behalf of Glory Communications, Inc. ("GCI"), licensee of station WEAJ, 1130 kHz, Camden, South Carolina. GCI is submitting a minor change application proposing to change the community of license of WEAJ from Camden, South Carolina to Springdale, South Carolina. As such, a radio ownership analysis is needed. The proposed new community of license is located in a metro county in the Columbia, South Carolina Arbitron market. GCI also the licensee of stations WGCN, 620 kHz, Cayce, South Carolina and WFMV, Channel 237A, South Congaree, South Carolina.¹ WGCN and WFMV are also licensed to communities in metro counties in the Columbia, South Carolina Arbitron market. As such, a review of the number of stations in the Columbia, South Carolina market will be conducted to show the proposed combination is in compliance with the rules.

2. As shown on Exhibit #1, there are thirty AM and FM (commercial and non-commercial) stations listed in the Columbia, South Carolina Arbitron Market. GCI would be in control of one FM station and two AM stations in the market. The number of stations indicated falls in the thirty to forty-five stations tier of §73.3555(a)(1)(ii) of the Commission's rules. At this level, common ownership or control of up to seven stations, with no more than four in the

1) GCI is also the licensee of WLJI, Summerton, South Carolina. WLJI had previously been designated "home" in the Columbia, South Carolina market. GCI has attributable interests in other AM and FM stations in South Carolina. However, none of the attributable Columbia, South Carolina metro stations have contour overlap with any other Glory stations located outside the metro market. As such, no contour overlap analysis is needed.

same service, is permissible. Therefore, control of stations WEAJ, WGCY and WFMV is believed to be in compliance with the Commission's radio ownership rules.² As such, the minor change for WEAJ is in compliance with the ownership requirements.

3. The foregoing technical statement was prepared for Glory Communications, Inc., by Graham Brock, Inc. All information contained herein is true and accurate to the best of our belief and knowledge. All data relating to AM and FM facilities in the relevant BIA/Arbitron market was determined using the BIA Financial Network, Inc. Media Access Pro, Version 4.2. BIA database. We assume no liability for errors or omissions in that database which may be adverse to the information contained herein.

2) Considering WLJI, GCI would be in control of two FM and two AM stations, which would also be in compliance with the ownership rules for the Columbia, South Carolina market.


