FBC is the sole member of Fisher Broadcasting - Seattle TV, L.L.C.; Fisher Broadcasting - Seattle Radio, L.L.C.; Fisher Broadcasting - Portland TV, L.L.C.; Fisher Broadcasting - Oregon TV, L.L.C.; Fisher Broadcasting - Washington TV, L.L.C.; Fisher Broadcasting - Idaho TV, L.L.C.; and Fisher Broadcasting - S.E. Idaho TV, L.L.C.

Fisher Broadcasting - Seattle TV, L.L.C. is the licensee of KOMO-TV, Seattle, Washington (FIN #21656).

Fisher Broadcasting - Seattle Radio, L.L.C. (“FBSR”) is the licensee of KOMO(AM), Seattle, Washington (FIN #21647), KVI(AM), Seattle, Washington (FIN #35853), and KPLZ-FM, Seattle, Washington (FIN #21663).
