MBC Grand Broadcasting, Inc. ("MBC Grand"), is the licensee of AM broadcast stations KNZZ (Facility No.39465) and KTMM (Facility No. 47151), and FM broadcast stations KJYE (Facility No. 39464), KMOZ-FM (Facility No. 81556), and KMGJ (Facility No. 47115) all licensed to Grand Junction, Colorado, and AM broadcast station KDTA, Delta, Colorado (Facility No. 6606). An application (File No. BAL-20040813AAR) is pending for the assignment of KDTA to United Ministries. Pending the assignment proposed in this application, MBC Grand holds the right to selling advertising time on KSTR-FM pursuant to a Joint Sales Agreement.

Richard C. Dean is Chairman of the Board of Directors, CEO, and holder of 70.3 percent of the voting stock of MBC Grand. (MBC Grand has a single class of voting stock.) Mr. Dean is also Chairman of the Board, CEO, and owner of 54.4 percent of the voting stock of Maranatha Broadcasting, Inc. ("MBC"), licensee of television broadcast station WFMZ-TV, Allentown, Pennsylvania (Facility No. 39884) and AM broadcast station WEST, Easton, Pennsylvania (Facility No. 36996). (MBC Grand has two classes of stock, one of which is non-voting. Mr. Dean owns 39.2 percent of all of the stock of MBC, voting and non-voting.)

David G. Hinson, President and a director and owner of 3.1 percent of the voting stock of MBC Grand, is Secretary of MBC, a director, and owner of 4.8 percent of its voting stock (5.9 percent of total stock, voting and non-voting).

Michael Kulp, Secretary-Treasurer and Chief Financial Officer and a director of MBC Grand and owner of 3.1 percent of its voting stock, is Treasurer and CFO and a director of MBC and owner of 4.0 percent of its voting stock (5.7 percent of total stock, voting and non-voting).

Barry Fisher, a director of MBC Grand and holder of 3.1 percent of its voting stock, is President of MBC, a director, and holder of 4.8 percent of its voting stock (5.9 percent of total stock, voting and non-voting).

Richard A. Dean and Wendy Shubert are each directors of MBC Grand and each owns 3.1 percent of its voting stock. Each is a director and owns 8.0 percent of the voting stock of MBC (9.3 percent of total stock, voting and non-voting). JoAnna Dean is a director of MBC Grand and of MBC but does not own stock in either company.
