

NOTIFICATION OF OWNERSHIP CHANGE (FCC FACILITY No. 49237)

RE: CHANGE OF OWNERSHIP OF FCC FACILITY #49237 – WKSJ-LD, Trion/Summerville, GA

The following document serves as notification of an immediate change of ownership of FCC facility 49237 from Altenga Broadcasting, LLC to Narrow Path Productions, Inc. (a Georgia S-incorporation). Both of these entities are entirely owned by Scott Hicken, who wishes to transfer ownership of FCC facility 49237 from Altenga Broadcasting, LLC to Narrow Path Productions, Inc.

Facility 49237 includes the following:

- **An application for a displacement Construction Permit for WKSJ-TV/LD to move to Channel 17 with increased power limits**

Narrow Path Productions, Inc. has agreed to purchase the following from **Robert Lipop**:


40% share of Altennga Broadcasting, LLC, which represents the entirety of Robert Lipop's ownership stake in Altennga Broadcasting, LLC.

In return for **Robert Lipop's** ownership share of **Altennga Broadcasting, LLC**, **Narrow Path Productions, Inc.** agrees to give **Robert Lipop** the following:


- \$32,500 cash (payable on June 28, 2019)
- Twelve equal payments of \$2792/month commencing August 1, 2019 (\$33,504 total)
- Ownership of NewTek 3Play440 with CS (SN: NA1145389041160 with Amitrace hardware warranty ending 8/14/19). Ownership of equipment and current lease arrangement with Echo Entertainment transfers to Robert Lipop on June 28, 2019.

NOTE: Narrow Path Productions, Inc. stipulates that it owns the listed equipment (NewTek 3Play440) free and clear of any liens, loans or other debts.

Narrow Path Productions, Inc. further stipulates that upon the date of the signing of this agreement, **Robert Lipop** will no longer be held liable for 40% of the remaining payment for WKSJ-TV (\$83,250), which is currently owned by **Altennga Broadcasting, LLC**.
