First Broadcasting Capital Partners, LLC (“First Broadcasting”), licensee of Station WAOL(FM), Ripley, Ohio, and Educational Community Radio, Inc. (“ECR”), licensee of Station WOBO(FM), Batavia, Ohio, hereby submit these contingent applications, which propose to (i) delete Channel 258C3 at Ripley, Ohio and allot Channel 258A to Amelia, Ohio as that community’s first local service, and (ii) relocate the transmitter site for Station WOBO on Channel 204B.

I. WAOL(FM), Ripley, Ohio to Amelia, Ohio.

As demonstrated in the Technical Exhibit, Channel 258C3 can be allotted to Amelia consistent with Section 73.207 of the Commission’s Rules. A 70 dBu signal can be provided to Amelia from the proposed reference coordinates. The area and population within the proposed 70 dBu contour is 841 sq. km and 125,285 persons, and within the proposed 60 dBu contour is 2,524 sq km and 467,745 persons. There are 24 stations providing protected service to Amelia. The relocation of WAOL(FM) from Ripley will result in a predicted net gain in population of 345,874 persons within the Station’s proposed 60 dBu contour. The relocation of WOBO(FM) will result in a predicted net gain in population of 103,235 persons within the Station’s proposed 60 dBu contour. Thus, taken together, the relocation of WAOL(FM) and WOBO(FM) will result in a predicted net gain in population of 449,109 persons within the Stations’ proposed 60 dBu contours. *See* Engineering Exhibits.

First Broadcasting desires to change the community of license of the Station from Ripley to Amelia under the guidelines set forth in *Amendment of the Commission’s Rules Regarding Modification of FM and TV Authorizations to Specify a New Community of License*, 4 FCC Rcd

4870 (1989), *recons. granted in part*, 5 FCC Rcd 7094 (1990).¹ There, the Commission stated that a station may change its community of license without subjecting the license to other expressions of interest if (1) the proposed allotment is mutually exclusive with the current allotment; (2) the current community of license will not be deprived of its only local service; and (3) the proposed arrangement of allotments is preferred under the Commission's allotment priorities. These criteria are met here. First, the proposed use of Channel 258A at Amelia is mutually exclusive with the current use of Channel 258C3 at Ripley. Second, Ripley will not be deprived of its only local service because, Station KELE(AM), Mountain Grove, Missouri has filed an application to change its city of license from Mountain Grove to Ripley. *See* BMJP-20051031AFI.² Third, the provision of a first local service at Amelia (2000 U.S. Census population 2,752) under Priority 3 will result in a preferential arrangement of allotments over the retention of a second local service at Ripley (2000 U.S. Census population 1,745) under Priority 4. *See Revision of FM Assignment Policies and Procedures*, 90 FCC 2d 88 (1982).

Amelia is located in the Cincinnati, Ohio Urbanized Area. Therefore, this relocation implicates the Commission's policy against migration of stations from rural to urban areas. *See Faye and Richard Tuck*, 3 FCC Rcd 5374 (1988).

In making the determination whether to award an urbanized community a first local service preference, the Commission will consider (1) the extent to which the station will provide service to the entire Urbanized Area, (2) the relative populations and proximity of the suburban and central city, and, most importantly, (3) the independence of the suburban community. *Tuck*, 3 FCC Rcd at 5377-78. In this case, from the proposed transmitter site, Station WAOL(FM) will

place a 70 dBU contour over 50% of the Cincinnati Urbanized Area. Amelia's population (2000 U.S. Census 2,752) is less than 1% of that of Cincinnati (2000 U.S. Census 331,285). Amelia is located approximately 15 miles from Cincinnati. These figures demonstrate independence and exceed those of other suburban communities granted a first local preference. *See e.g., Park City, Montana*, 19 FCC Rcd 2092, 2094 (2004) (Park City's population is less than 1% of that of Billings, and Park City is located 21 miles from Billings); *Ada, Newcastle and Watonga, Oklahoma*, 11 FCC Rcd 16896, 16899 (1996) (Newcastle's population is less than 1% of that of Oklahoma City, and Newcastle is located 15 miles from Oklahoma City). Nevertheless, the Commission has repeatedly stated that these factors are less important than evidence of independence. *See Headland, Alabama and Chattahoochee, Florida*, 10 FCC Rcd 10352 (1995). The following analysis of the eight *Tuck* factors demonstrates the independence of Amelia from Cincinnati.

(1) ***Extent to which the residents of Amelia work in Amelia.*** According to 2000 U.S. Census figures, 82 of the 1,446 employed individuals in Amelia, or 6%, work in Amelia. As shown below, there are many employers in Amelia who provide ample opportunities for Amelia residents to be employed in Amelia and not in Cincinnati. This alleviates any concerns that Amelia is dependent on Cincinnati for the employment of its residents. *See Lebanon and Speedway, Indiana*, 17 FCC Rcd 25064, 25065 (2002). *See Exhibit 1.*

(2) ***Newspapers and other media that cover Amelia's local needs and interests.*** *The Clermont Community Journal* and *The Clermont Sun* are weekly publications that cover the local needs and interests of Amelia. *The Clermont Community Journal* contains a separate section on Amelia that includes the local news report and the weekly police report. There are over 17 rack locations across Amelia where the residents of Amelia can purchase the newspaper. In addition

to the services of two regional newspapers, Amelia maintains its own webpage at <http://www.ameliavillage.com> that enables the residents of Amelia to access a wide variety of information concerning Amelia, including information regarding village officials, public services, public and committee meetings, and community events. *See Exhibit 1.*

(3) ***Community leaders and residents perceive Amelia as being separate from Cincinnati.*** Amelia has its own unique identity and history that is separate from that of Cincinnati. Amelia is located in Clermont County and is named after Amelia Bowdoin, the wife of the town's tollgate keeper. Early settlers arrived in what today is Amelia in the early 1800s and named the town Mill Town. The name was soon changed to Milton, and then in 1836 it was again changed to Amelia with the establishment of the first post office. Amelia was incorporated on December 20, 1900. The present day Mayor of Amelia is Mike Scharf, who characterizes Amelia as a "continually growing" community where residents can enjoy a variety of village-sponsored events, parks, and recreational facilities. *See Exhibit 1.*

(4) ***Amelia has its own local government and elected officials.*** The Village of Amelia operates independently of any other government, and is run by the Mayor and village council. The Council is composed of six members elected in an at-large, staggered election held every two years. Each Council member is elected to a four-year term. The Council's primary responsibilities are legislative – they establish the laws and rules of Amelia and determine how money is spent. The Mayor, also elected to a four-year term, is the chief executive officer of Amelia and is responsible for administering the laws adopted by the Council. The Mayor also appoints all Village Personnel with the confirmation of the Council. The town also has a Clerk, Treasurer, Street Commissioner, Recreation Commission, and Planning Commission. *See Exhibit 1. See Exhibit 1.*

(5) *Amelia has its own zip codes, post office, and phone directories.* The United States Postal Service has assigned zip code 45102 to Amelia and it operates an office in Amelia. Amelia is included in the Clermont County Phone Book, which contains yellow and white page directories for a number of communities, including Amelia. This phone book does not include listings for Cincinnati. *See Exhibit 1.*

(6) *Amelia has its own commercial establishments, community organizations, and health care providers.* Amelia is home to a variety of commercial establishments. The Amelia Business Association provides a listing of businesses located in Amelia and serving the community of Amelia. A number of local businesses identify with the community by using “Amelia” in their name, including Amelia Florist, Amelia Locksmiths Inc., and Amelia Pet Clinic. Other Amelia retail and commercial businesses include Bard Nurseries, Campbell and Associates Insurance Agency Inc., DeWeese Upholstery, Eagle Coach Company, Golden Rule Catering, Hurst Printing, Luke’s Sewing Center, Terry’s Carpet Plus, and Red Dog Salon. Dining establishments in Amelia include Abbott’s Family Restaurant, Bob’s Pizza, and Grammas Pizza. Banks located in Amelia include the First Clermont Bank, New Richmond National Bank, Bank One, and Fifth Third. *See Exhibit 1.*

A number of health care providers are located in Amelia. Medical services and dental services are provided by a number of sole practitioners. Amelia is also home to a number of religious organizations, such as Amelia United Methodist, Central Baptist, Friendship Lutheran Church, and Ohio Pike Church of God. Community organizations in Amelia include the Amelia Area Historical Society, American Legion, and Amelia Youth Athletic Club. *See Exhibit 1.*

(7) *Amelia is a separate and distinct advertising market from Cincinnati.* *The Clermont Community Journal* and *The Clermont Sun* provide the businesses of Amelia with a

place to advertise to the residents of Amelia without relying on Cincinnati. *The Clermont Community Journal* provides advertising space in the hardcopy versions of its paper and on its websites. *See* Exhibit 1.

(8) ***Amelia has its own schools, libraries, police protection, and fire protection.*** The West Clermont School District serves the residents of Amelia with the following schools located in Amelia: Amelia Elementary, Amelia Middle School, McNicholas High School, Amelia High School, and St. Bernadette School. The Clermont Country Public Library system has a branch in Amelia. The Amelia Branch location is open six days a week and provides the residents of Amelia with traditional library services. Police services are provided to the residents of Amelia by the Village of Amelia Police Department and fire services are provided by the Union Township Fire Department. The Village of Amelia Police Department employs 10 officers and its mission is to work in partnership with the community to provide a safe and secure environment. *See* Exhibit 1.

For the foregoing reasons the Commission should delete Channel 258C3 at Ripley, Ohio and allot Channel 258A at Amelia, Ohio as that community's first local service.

The changes proposed in these contingent application would provide Amelia with its first local service. As the proposed changes constitute a preferential arrangement of allotments under 307(b) the Commission should delete Channel 258C3 at Ripley, Ohio, and allot Channel 258A at Amelia, Ohio as that community's first local service.

History of Amelia

Condensed by Cliff Hughes, Co-Historian

The early settlers came from Maine, New Jersey and Massachusetts.

David Jernegan and John Butler built a saw mill in the vicinity of the present day Methodist Church. The area was called Mill Town and soon was changed to Milton and was changed again to Amelia when the Post Office was established (Feb. 25, 1836). This change was in honor of Amelia, the wife of Wesley Bowdoin, the tollgate keeper.

Mr. Robinson, an undertaker, owned a large track of land in the middle of the area. He had the timber cut and sawed for caskets. His wife made the linings. Mr. Robinson donated a portion of his land for a school. It was agreed that if it was ever used for anything else, it would revert back to him or his heirs.

There were five graduates in the first class (1893). Ninety five years later (1988) there were five hundred, twenty three graduated from the West Clermont School District, (Amelia & Glen Este).

All Amelia School activities, plays, graduations, and basketball games were held in the building at 41 W. Main St., known as Town Hall and later as Amelia Outlet. In 1931 a new school building was erected and future school activities were held in a new gym.

The Post Office has been in seven different locations and has had twenty six Postmasters in one hundred and sixty years.

There have been many businesses over the past years and as of Nov. 1996 there were eighty five within the corporation.

Over the years there have been many places of worship in the vicinity, but Amelia proper area has only two, the Methodist and Baptist.

For entertainment there were Ice Cream Socials, Taffy Pulls, Band Concerts, Pool Rooms, Silent Movies, Medicine Shows, and Boxing Matches. The building at 30 W. Main St. (The World of Wood) was used for the Boxing Matches.

The I.O.O.F. Lodge was organized in 1848 and moved into their building at the corner of St. Rt. 125 (Main St.) and Oak St. Later they purchased the building at 41 W. Main St.

(Town Hall). This was sold to the Masonic Lodge in 1950 when their membership moved to Batavia.

The first Masonic Lodge #299 was organized in 1858 but went down in 1865 due to lack of attendance. The second Masonic Lodge, Amelia 590 was started in 1904.

Upon checking various records, Amelia is the youngest, Incorporated town in Clermont County. It was incorporated on Dec. 20, 1900.

GENERAL PROVISIONS

§ 31.01 EXECUTIVE POWER; WHERE VESTED.

The executive power and authority of the municipality shall be vested in the Mayor, Clerk, Treasurer, Marshal, Street Commissioner, and such other officers and departments as are created by law.

MAYOR

§ 31.05 TERM OF MAYOR; POWERS AND DUTIES.

The Mayor shall be elected for a term of four years commencing on the first day of January next after his or her election. He or she shall be an elector of the municipality, and shall have resided in the municipality for at least one year immediately preceding his or her election. He or she shall be the chief conservator of the peace within the municipality, and shall have the powers and duties provided by law. He or she shall be the President of the

Legislative Authority, and shall preside at all regular and special meetings thereof, but shall have no vote except in case of a tie.

§ 31.06 GENERAL DUTIES OF THE MAYOR.

The Mayor shall perform all the duties prescribed by the bylaws and ordinances of the municipality. He or she shall see that all ordinances, bylaws, and resolutions of the Legislative Authority are faithfully obeyed and enforced. He or she shall sign all commissions, licenses, and permits granted by the Legislative Authority, or authorized by Title VII of the Revised Code, and such other instruments as by law or ordinance require his or her certificate.

§ 31.07 COMMUNICATIONS TO THE LEGISLATIVE AUTHORITY.

The Mayor shall communicate to the Legislative Authority from time to time a statement of the finances of the municipality, and other information relating thereto, and the general condition of the affairs of the municipality as he or she deems proper, or as is required by the Legislative Authority.

§ 31.08 PROTEST AGAINST EXCESS OF EXPENDITURES.

If, in the opinion of the Mayor, an expenditure authorized by the Legislative Authority exceeds the revenues of the municipality for the current year, he or she shall protest against the expenditure and enter the protest, and the reason therefor, on the journal of the Legislative Authority.

§ 31.09 SUPERVISION OF CONDUCT OF OFFICERS.

The Mayor shall supervise the conduct of all the officers of the municipality, inquire into and examine the grounds of all reasonable complaints against any officers, and cause their violations or neglect of duty to be punished promptly or reported to the proper authority for correction.

§ 31.20 ELECTION, TERM, QUALIFICATIONS OF THE CLERK.

The Clerk shall be elected for a term of four years, commencing on April 1 next after his or her election. He or she shall be an elector of the municipality.

§ 31.21 POWERS AND DUTIES OF CLERK.

(A) The Clerk shall attend all meetings of the Legislative Authority and keep a record of its proceedings and of all rules, bylaws, resolutions, and ordinances passed or adopted, which shall be subject to the inspection of all persons interested. In case of the absence of the Clerk, the Legislative Authority shall appoint one of its members to perform his or her duties.

(B) The Clerk shall attend training programs for new clerks and annual training programs of continuing education for clerks that are provided by the Auditor of State pursuant to R.C. § 117.44.

§ 31.22 BOOKS AND ACCOUNTS; MERGER OF OFFICES.

The Clerk shall keep the books of the municipality, exhibit accurate statements of all moneys received and expended, of all the property owned by the municipality and the income derived therefrom, and of all taxes and assessments. The Legislative Authority may, by majority vote, merge the duties of the Clerk of the Board of Trustees of Public Affairs with those of the Clerk, allowing the Clerk such additional assistance and compensation in

election at which the Clerk would have been elected and each four years thereafter, the Clerk-Treasurer shall be elected for a term of four years, commencing on the first day of April following the Clerk-Treasurer's election. The Clerk-Treasurer shall be an elector of the municipality.

(C) The Clerk-Treasurer shall perform the duties provided by law for the Clerk and the Treasurer. All laws pertaining to the Clerk and to the Treasurer shall be construed to apply to the Clerk-Treasurer, provided that the initial compensation for the office of Clerk-Treasurer shall be established by the Legislative Authority and that action shall not be subject to R.C. § 731.13 relating to the time when the compensation of elected officials shall be fixed and pertaining to changes in compensation of officials during the term of office.

(D) If and when the municipality has a Clerk-Treasurer, the Legislative Authority may separate the offices by ordinance or resolution passed by at least a majority vote. The action to separate the offices may be taken in either of the following circumstances:

(1) When a vacancy exists in the office of Clerk-Treasurer, in which case the separation shall be effective upon the effective date of the ordinance or resolution.

(2) When the action of the Legislative Authority is certified to and filed with the Board of Elections not less than 105 days before the day of the next primary election at which the Clerk and Treasurer are to be elected, provided that in villages under 2,000 population in which no petition for a primary election was filed pursuant to R.C. § 3513.01, or in villages in which no primary is held pursuant to R.C. § 3513.02, such action shall be certified to the Board of Elections not less than 105 days before the next general election at which the Clerk and Treasurer are to be elected.

The Treasurer shall be elected for a term of four years, commencing on January 1 next after his or her election. He or she shall be an elector of the municipality.

The Treasurer, at the expiration of his or her term of office, or on his or her resignation or removal, shall deliver to his or her successor, all moneys, books, papers, and other property in his or her possession as Treasurer. In the case of the death or incapacity of the Treasurer, his or her legal representatives shall, in like manner, deliver the money and property which were in the Treasurer's hands to the person entitled thereto.

STREET COMMISSIONER**§ 31.40 QUALIFICATIONS.**

(A) So long as the municipality has not provided for the appointment of an Administrator under R.C. § 735.271 or a substantially equivalent municipal ordinance, a Street Commissioner shall be appointed by the Mayor and confirmed by the Legislative Authority for a term of one year. He or she need not be a resident of the municipality at the time of his or her appointment, but shall become a resident thereof within six months after his or her appointment and confirmation, unless the residence requirement is waived by ordinance. Vacancies in the office of Street Commissioner shall be filled by the Mayor for the unexpired term.

(B) The appointment of a Street Commissioner shall include a probationary period of six months. If an appointment is made for an unexpired term, and if the same Street Commissioner is reappointed at the end of that term, the probationary period shall continue into his or her next term. No appointment is final until the appointee has satisfactorily completed his or her probationary period. If the service of the appointee is unsatisfactory during the probationary period, he or she may be removed by the Mayor and the reasons for the removal shall be communicated to the Legislative Authority. If a person is appointed to successive terms as Street Commissioner, he or she shall serve only one six month probationary period during those successive terms.

(C) The Marshal shall be eligible to appointment as Street Commissioner.

GENERAL PROVISIONS

§ 32.01 MEMBERS OF THE LEGISLATIVE AUTHORITY; ELECTION; TERMS OF OFFICE.

The legislative power of each municipality shall be vested in, and exercised by, a Legislative Authority, composed of six members, who shall be elected by the electors of the municipality at large, for terms of four years.

The Amelia Planning Commission serves a vital roll in the development of our Community, by reviewing issues such as Zone changes, sites plans under normal zoning laws, and site plans under Plan Unit Development (PUD). When a developer wants to create a new development, it is the responsibility of the planning commission to make sure that the proposed development: 1. is consistent with the Village Comprehensive Plan, adopted by Village Council in 2001, 2. all site plans are reviewed by Village Engineer (CDS Associates Inc.), and corrections made. 3. All studies needed are completed, for example: traffic studies, wetland reviews by the EPA, or even soil density test, and if the development is laid out properly with parks, walking trails, and other amenities of that nature. All issues once completed are sent to Council with a recommendation.

Parks - Amelia Village owns and operates the Robert W. Groh Community Park located on Huntsman Trace in the Quail Creek Subdivision, a 5-acre park, which provides a basketball court, picnic areas, pavilion, walking trails, and playground equipment. The Village also owns a 20-acre parcel in the Hedona Ridge Subdivision on Robin Way and Canary Drive, which is its infancy of Development. The 'Spencer Shank Memorial Park' shall begin its first phase of development. This property, at the present time, is undeveloped but the Recreation Commission is making plans to develop this property into a park in the near future, as funding permits. Future plans call for kid's playground, ballfields, basketball, tennis, walking trails, frisbee golf, pavilions and an amphitheater.

The Village also leases from West Clermont School District, two ball fields, and youth football facilities behind Amelia Elementary School. These facilities are managed by the Amelia Recreation

Quail Creek PUD II Greenspace

As part of the Quail Creek PUD II subdivision plan there are plans to provide almost thirty acres for greenspace and recreational facilities. Most of this thirty acres will consist of natural greenspace throughout the subdivision with a chipped walking trail throughout. There is also planned to a small gazebo with Children's play area near Grouse/Arrowhead and a small picnic shelter with recreation eas near a small pond in future phases near Jenny Lind Rd and Lyons Rd.

Amelia Village Recreation Commission also leases from the West Clermont School District the ballfields behind the Amelia Elementary School. The Village manages and maintains these facilities for the benefit of the children of the Amelia area. The Village provides all of these facilities at no charge to the community.

Amelia Park Subdivision

The developers of the Amelia Park Subdivision have planned a small 2-3 acre parcel that will be dedicated to the Village upon its completion. The current plan for this parcel is to keep it in its natural state due to the limitations of the surrounding topography.

History of the Amelia Business Association

The Amelia Business Association meets at 8.00 am on the second Thursday of each month at Abbott's Family Restaurant.

The Amelia business area, along with the surrounding area, began to grow immensely in the early 1980's. A handful of local business people and a few Village council members saw a need to work together, to promote and to advance the core business area.

Late in 1991 this small group got together to decide how best to address this challenge. After a number of preliminary meetings the idea of a Business Association was accepted as the best method to achieve everyone's desires. A small deposit was made in February 1992 to start the Association.


At the Feb. 11, 1993 meeting the Association voted on and passed the "Code of Regulations". The Amelia Business Association was the accepted name. From its beginnings the few businesses involved worked hard, not only to invite other businesses in but to promote the area to outsiders. It was apparent that if they were to accomplish anything, membership was a priority. This they actively addressed.

In 1994, with membership growing, the association voted to accept the proposed "Articles of Incorporation" which were then presented by the Board of Directors with Terrance Monnie as the legal advisor. Work began on a Mission Statement and a few months later that statement was approved.

The association has accomplished a number of things in these early years. It has worked to support education, to promote the area to new businesses and builders. It has been involved in area contest and sponsored the first Great Amelia Steak Out. It provided funds to begin the Chatterbox, a monthly area letter. It has donated two special bikes to the Amelia Police Department and the necessary items to go along with the bikes. It supports the Annual Amelia Christmas Parade. It hosts a Christmas Party for its members. In 1997 the first ABA Directory was introduced at the Christmas Party. Membership doubled in 1998 and continued to grow in 1999. In 1999 the first golf outing to raise money for the Scholarship Fund was held and will become an annual event. Evening get together socials are planned for the new Millennium.

Union Township Offers Smoke Detectors to Amelia Village Residents

The Union Township Fire Department has smoke detectors available to residents of Amelia Village. Residents of the village in need of a smoke detector can pick one up at the Amelia Municipal Building during normal business hours; a waiver must be completed and proof of residency must be presented. Smoke detectors should be placed in the hallway at ceiling level outside sleeping areas. For further information please contact the Amelia Municipal building or call 513-753-4747.



FYI...

In the event of a fire or medical emergency in the Village of Amelia, at the same time emergency equipment is being sent to you, an Amelia Police Officer is also dispatched.

In addition to the first aid training officers were taught in the police academy, all Amelia Police Officers have completed the *American Heart Association's Heartsaver First Aid with CPR and AED* course. Two of our officers have also completed the First Emergency Responder class offered at Clermont College. Our on-duty officers have an automated external defibrillator (AED) in the patrol car at all times, along with a first aid kit and fire extinguisher.

We also have direct radio contact with the responding paramedic unit or fire truck to provide them instant on-scene updates on any information that may have not been known at the time the original call came in.

The American Heart Association estimates that about 220,000 people die each year from sudden cardiac arrest. For every minute that passes without defibrillation, a victim's chances of survival decrease by 7-10 percent. AED's are also located in the Amelia Elementary School and our Municipal Building.
