- 2 The relative field strength of the measured vertically polarized radiation component shall not exceed at any azimuth the value indicated on the composite radiation pattern authorized by this construction permit.

A relative field strength of 1.0 on the composite radiation pattern herein authorized corresponds to the following effective radiated power:

0.150 kilowatt. (vertical only)

Principal minima and their associated field strength limits:

180 degrees True through 320 degrees True: 0.0048 kilowatt.

- 3 Grant of this license application is conditioned on the continuous operation of the licensed facility for the twelve-month period following grant. The failure of the facility to so operate will result in the rescission of this grant, dismissal of the license application and the forfeiture of the associated construction permit pursuant to 47 C.F.R. § 73.3598(e) unless the licensee rebuts the presumption that the authorized facilities were temporarily constructed.
