TECHNICAL STATEMENT

1. This Technical Statement and attached exhibits were prepared on behalf of Millennium Radio Holdings, LLC in connection with the proposed transfer of control of Millennium Shore License Holdco LLC, licensee of WADB, 1310 kHz, and WJLK, Channel 232A, Asbury Park, New Jersey; WOBM, 1160 kHz, Lakewood Township, New Jersey; WOBM-FM, Channel 224A, Toms River, New Jersey; and WCHR-FM, Channel 289B1, Manahawkin, New Jersey; Millennium Atlantic City License Holdco LLC, licensee of WENJ, 1450 kHz; WFPG, Channel 245B, and WPUR, Channel 297B1, Atlantic City, New Jersey; Millennium Atlantic City II

Holdco LLC, licensee of WENJ-FM, Channel 247B, Millville, New Jersey; Millennium Central New Jersey License Holdco LLC, licensee of WKXW, Channel 268B, Trenton, New Jersey; and Millennium Egg Harbor License Holdco LLC, licensee of WSJO, Channel 285B1, Egg Harbor City, New Jersey. All five licensees are hereinafter jointly referred to as Millennium.

2. WADB and WJLK are both licensed to communities in Monmouth County New Jersey, which is a metro county in the New York, New York Arbitron Market and a metro county in the Monmouth-Ocean, New Jersey Arbitron Market. WOBN, WOBN-FM, and WCHR-FM are licensed to a metro county in the Monmouth-Ocean, New Jersey Arbitron Market. WENJ, WFPG, WPUR and WSJO are licensed to communities in a metro county in the Atlantic City-Cape May, New Jersey Arbitron. WENJ-FM is not licensed to a community in any metro county, but is considered “home” to the Atlantic City-Cape May, New Jersey Arbitron Market. WKXW is licensed to a metro county in the Trenton, New Jersey Arbitron Market. Therefore, this review will verify compliance of commonly owned stations in both rated and non-rated markets.

NEW YORK, NEW YORK ARBITRON/BIA MARKET REVIEW

3. As shown on Exhibit #1, there are 150 AM and FM (commercial and non-commercial) stations listed in the New York, New York Arbitron Market (Market #1). Millennium would control one AM station and one FM station in the market (WADB and WJLK). The number of stations indicated falls in the forty-five or more stations tier of §73.3555(a)(1)(i) of the Commission's rules. At this level, common ownership or control of up to eight stations, with no more than five in the same service, is permissible. Therefore, Millennium is in compliance in the rated New York, New York market.

MONMOUTH-OCEAN, NEW JERSEY ARBITRON/BIA MARKET REVIEW

4. As shown on Exhibit #2, there are 24 AM and FM (commercial and non-commercial) stations listed in the Monmouth-Ocean, New Jersey, Arbitron Market (Market #51). Millennium would control two AM stations and three FM stations in the market (WADB, WJLK, WOBM, WOBM-FM and WCHZ-FM). The number of stations indicated falls in the fifteen to twenty-nine stations tier of §73.3555(a)(1)(iii) of the Commission's rules. At this level, common ownership or control of up to six stations, with no more than four in the same service, is permissible. Therefore, Millennium is in compliance in the rated Monmouth-Ocean, New Jersey.

ATLANTIC CITY-CAPE MAY, NEW JERSEY ARBITRON/BIA MARKET REVIEW

5. As shown on Exhibit #3, there are 36 AM and FM (commercial and non-commercial) stations listed in the Atlantic City-Cape May, New Jersey, Arbitron Market (Market #142). Millennium would control four FM stations and one AM station in the market (WENJ, WFPG, WPUR, WENJ-FM and WSJO). The number of stations indicated falls in the thirty to forty-four stations tier of §73.3555(a)(1)(ii) of the Commission's rules. At this level, common ownership or control of up to seven stations with no more than four in the same service is permissible. Therefore, Millennium is in compliance in the rated Atlantic City-Cape May, New Jersey market.

TRENTON, NEW JERSEY ARBITRON/BIA MARKET REVIEW

6. As shown on Exhibit #4, there are 12 AM and FM (commercial and non-commercial) stations listed in the Trenton, New Jersey Arbitron Market (Market #143). Millennium controls one FM station in the market (WKXW). The number of stations indicated falls in the fourteen or fewer stations tier of §73.3555(a)(1)(iv) of the Commission's rules. At this level, common

ownership or control of up to five stations, with no more than three in the same service, provided the number of stations to be commonly held does not exceed 50% of the stations in the market, is permissible. Therefore, Millennium is in compliance in the rated Trenton, New Jersey market.

CONTOUR OVERLAP ANALYSIS

7. WENJ-FM is considered “home” to the Atlantic City-Cape May, New Jersey Market and does have contour overlap with other stations in that market. The city grade contours of the subject stations considered in the contour overlap analysis are shown on Exhibit #5.¹ As noted, the locations of the city grade contours of the stations create a single radio market requiring review. The Radio Market consists of FM stations WENJ-FM, WSJO, WPUR, WFPG, and AM station WENJ.

8. The city grade contours of the five subject stations will be used to determine the Radio Market Boundary. These contours will be used to determine the number of other stations in the relevant market to which the subject stations in the respective market will then be added to reach the total number of stations in, or providing service to, the respective market. No stations with transmitters located more than 92.0 kilometers from the boundary of the common overlap of subject stations will be considered. Further, no other facility controlled by Millennium will be considered as a market contributor, unless it is a subject station in the radio market under study.

1) WENJ-FM only has contour overlap with WSJO, WPUR, WFPG, and WENJ. The remainder of the attributable stations in the other rated markets do not have contour overlap with WENJ-FM and are, therefore, not considered further in this overlap review.

9. Exhibit #6 is a depiction of the AM and FM stations (commercial and non-commercial) providing service to the Radio Market. Exhibit #7 is a tabulation of the stations in Radio Market. A total of seventeen stations are shown, including the five subject stations. The number of stations depicted falls in the fifteen to twenty-nine stations tier of 73.3555(a)(1)(iii) of the Commission's rules. At this level, common ownership or control of up to six stations with no more than four in the same service is permissible. Therefore, Millennium is in compliance in the non-rated Radio Market.

10. Based on the compliance shown in both the rated and non-rated markets, the proposed transfer of control of Millennium is in compliance with the Commission's rules, as it relates to the markets reviewed.

RADIO AND TELEVISION CROSS OWNERSHIP REVIEW

11. Principals of Millennium Radio Holdings, LLC have an attributable interest in the proposed assignee of WPIX, Channel 11, New York, New York and WPHL-TV, Channel 17, Philadelphia, Pennsylvania. Exhibits #8 (WPIX) and #9 (WPHL-TV) show the noise limited contours of these two TV stations. Exhibit #10 (WPIX) and #11 (WPHL-TV) show the 2.0 mV/m contours of all AM stations and the 60 dBu contours of each FM station.

12. As indicated, none of the Millennium radio stations provide either a 60 dBu (FM) or 2.0 mV/m daytime (AM) contour over the communities of license of either WPIX or WPHL-TV. However, WPIX does place a noise limited contour over the communities of Trenton, New Jersey;

Lakewood Township, New Jersey; Asbury Park, New Jersey; and Toms River, New Jersey.² The WPHL-TV noise limited contour encompasses the communities of Lakewood Township, New Jersey; Trenton, New Jersey; Toms River, New Jersey; Manahawkin, New Jersey; Egg Harbor City, New Jersey; and Millville, New Jersey. The community of Atlantic City, New Jersey is not completely encompassed by the noise limited contour.^{3,4} Based on this data, the radio and television cross ownership rules are triggered. A separate attachment has been prepared establishing that there are a sufficient number of independent “voices” in each market, thereby demonstrating that the proposed combination is permissible under the Commission’s radio/television cross-ownership rule.

13. The foregoing technical statement was prepared on behalf of Millennium Radio Holdings, LLC by Graham Brock, Inc., its Technical Consultants. All information contained herein is true and accurate to the best of our belief and knowledge. All data relating to AM and FM facilities in the relevant BIA/Arbitron market was determined using the BIA Financial Network, Inc. Media Access Pro, Version 4.52. BIA database. Technical data related to AM and FM facilities was extracted from the Commission’s CDBS database. We assume no liability for errors or omissions in either database which may be adverse to the information contained herein.

- 2) The remaining communities of Millville, New Jersey; Manahawkin, New Jersey; Atlantic City, New Jersey; and Egg Harbor City, New Jersey are beyond the WPIX contour.
 - 3) A very small portion, consisting of approximately 0.1 square kilometer of the boundary of Atlantic City falls outside the WPHL-TV contour. This is less than 1% of the area within the boundary of the city.
 - 4) Asbury Park, New Jersey is wholly outside the WPHL-TV contour.
