DESCRIPTION OF THE TRANSACTION; AGREEMENTS

Applications seeking the FCC's consent to the assignment of the following Class A television stations are being filed contemporaneously by the parties:

Submitted herewith are executed copies of an Asset Purchase Agreement (“APA”), a Local Marketing Agreement (“LMA”), a Technical Services Agreement (for WZDC-CD), and a Technical Services Agreement (for WRDM-CD). Also submitted is the form of a Transition Services Agreement (which is Exhibit F to the APA) that will be executed at closing. Financial information in Schedule A of the form of a Transition Services Agreement has been redacted and the other exhibits and schedules to the APA have been omitted as they contain confidential or proprietary information, or are otherwise not relevant to the FCC's or the public's consideration of the assignment application. *See* LUJ, Inc. and Long Nine, Inc., *Memorandum Opinion and Order*, 17 FCC Rcd 16980 (2002) and *Public Notice*, DA 02-2049, 17 FCC Rcd 16166 (2002). Copies of the omitted exhibits and schedules will be provided to FCC staff upon request.

It is noted that a Channel Sharing Agreement between the parties was filed with a construction permit application for WZDC-CD, Washington, DC (FIN 50347) to channel share with WRC-TV, Washington, DC (FIN 47904) (File No. 0000035987), which was granted by the FCC on December 19, 2017, and a Channel Sharing Agreement between the parties was filed with a construction permit application for WRDM-CD, Hartford, CT (FIN 10153) to channel share with WVIT, New Britain, CT (FIN 74170) (File No. 0000035989), which was granted by the FCC on December 19, 2017.

The parties respectfully request that the FCC process the instant assignment application for WZDC-CD and the assignment application for WRDM-CD independent of each other (and independent of the assignment applications referenced below).

It is also noted that applications seeking the FCC's consent to the assignment of the following full-power television, Class A television, low power television and TV translator stations were filed contemporaneously by the parties on December 4, 2017:
