TECHNICAL STATEMENT

1. This technical statement and attached exhibits were prepared on behalf of BMP RGV License Company, L.P. ("BMP"), licensee of KESO, Channel 224C2, and KZSP, Channel 237A, South Padre Island, Texas. BMP is submitting minor change applications for KESO and KZSP, as such, a Radio Market Analysis is necessary. BMP is also the licensee of KJAV, Channel 285A, Alamo, Texas; KURV, 710 kHz, Edinburg, Texas; and KVJY, 840 kHz, Pharr, Texas.¹ KESO, KZSP, KJAV, KURV and KVJY are each licensed to a community in a metro county in the McAllen-Brownsville-Harlingen, Texas Arbitron Market. Therefore, a review of a rated market is necessary.

ARBITRON/BIA RATED MARKET ANALYSIS

2. As shown on Exhibit #1, there are thirty-three AM and FM (commercial and non-commercial) stations listed in the McAllen-Brownsville-Harlingen, Texas Arbitron Market (Market #58).² BMP controls three FM stations and two AM stations in the market. The number of stations indicated falls in the thirty to forty-four stations tier of §73.3555(a)(1)(ii) of the Commission's rules. At this level, common ownership or control of up to seven stations,

with no more than four in the same service, is permissible. Therefore, the rated market is in compliance with the Commission's rules

3. Based on the above referenced review, the applications for KESO and KZSP are in compliance with §73.3555 of the Commission's multiple ownership rules.

4. The foregoing technical statement was prepared on behalf of BMP RGV License Company, L.P., by Graham Brock, Inc., its Technical Consultants. All information contained herein is true and accurate to the best of our belief and knowledge. All data relating to AM and FM facilities in the relevant BIA/Arbitron market was determined using the BIA Financial Network, Inc. Media Access Pro, Version 4.6. BIA database. All other data was extracted from the CDBS database. We assume no liability for errors or omissions in either database which may be adverse to the information contained herein.



His qualifications are a matter of record before the Federal Communications Commission. He has been active in Broadcast Engineering since 1979.


