Bank of America Corporation, NB Holdings Corporation and Bank of America, NA, as fiduciaries, possess shared voting and investment power as to shares of Company common stock under a number of wills, trusts and agency arrangements.

**O.D. FISHER INVESTMENT COMPANY**

O.D. Fisher Investment Company holds a 5.0228% interest in Fisher Communications, Inc., which in turn holds 100% of the common shares and 100% of the preferred shares of Fisher Broadcasting Company.

The Company does not take a direct, active role in the management of governance of Fisher Communications or of Fisher Broadcasting. The Company primarily is owned by the descendants of O.D. Fisher, one of the founders of Fisher Broadcasting, and their beneficiaries. No individual shareholder of the Company holds more than 14.39712% of the 1,198.83 outstanding shares of the Company, and thus none has an attributable interest in Fisher Broadcasting as a result of his or her shareholding in the Company.

The Commission should be aware that several of the above officers and directors hold direct ownership interests in Fisher Communications, Inc. and that Donald G. Graham, Jr. and Donald G. Graham, III serve as directors of Fisher Communications, Inc.

**GEORGE D. FISHER**

George D. Fisher owns 4,800 shares of Fisher Communications, Inc. stock. In addition, he shares voting and investment power as one of three trustees of the D.R. Fisher Trust, as to the 353,504 shares held by such trust. Mr. Fisher is also President and a director of the D.R. Fisher Company, which owns 171,464 shares of Fisher Communications, Inc. stock, and he shares voting and investment power with respect to such shares.

**ROBIN J. CAMPBELL KNEPPER**

Ms. Knepper owns 28,174 shares. In addition, she shares investment power as to the 436,731 shares held by the O.D. Fisher Investment Company. Ms. Knepper's husband owns 50 shares, and she disclaims beneficial ownership of the shares owned by her husband.

**EDWARD A GOWEY**

Mr. Gowey owns 1,200 shares jointly with his wife. In addition, he shares voting and investment power as one of three trustees of the D.R. Fisher Trust, as to the 353,504 shares held by such trust. Mr. Gowey is also an executive officer of the D.R. Fisher Company which owns 171,464 shares in which he has sole investment power with respect to such shares.

**GAMCO INVESTORS, INC.**

GAMCO Investors, Inc. (formerly Gabelli Asset Management Inc.), through its wholly-owned subsidiary GAMCO Asset Management Inc. and affiliates (Gabelli Funds, LLC, Gabelli Foundation, Inc., Gabelli Securities, Inc., Gabelli Advisers, Inc. and MJG Associates, Inc.) which are ultimately controlled by Mario J. Gabelli or Marc J. Gabelli (US citizens) and for which either acts as chief investment officer, including registered investment companies and pension plans, owns 1,503,571 shares (or approximately 17%) of outstanding stock of Fisher Communications, Inc. GAMCO Asset Management Inc., which is ultimately controlled by Mario Gabelli, holds 1,155,869 of the shares. GAMCO Investors, Inc. and its affiliates have no officers or directors in common with Fisher Communications, Inc. or its subsidiaries. See Exhibit 16 for other media interests.

**CASCADE INVESTMENTS, L.L.C.**

Cascade Investments, L.L.C. ("Cascade") is a 5.2% shareholder of Fisher Communications, Inc. All common stock held by Cascade may be deemed to be beneficially owned by William H. Gates, III, as the sole member of Cascade. Michael Larson, the manager and executive officer of Cascade has voting and investment power with respect to the common stock held by Cascade. Mr. Larson disclaims any beneficial ownership of the common stock beneficially owned by Cascade and Mr. Gates. Neither Cascade nor its principals hold attributable interests in any other broadcast facilities.

**Donald G. Graham, Jr., Director**

Mr. Graham owns 51,410 shares of Fisher Communication, Inc. stock.

Mr. Graham is President and a Director of O.D. Fisher Investment Company, which has an attributable interest in Fisher Communications, Inc. Mr. Graham votes the stock owned by O.D. Fisher Investment Company.

Mr. Graham has voting and investment power as to 36,960 shares held by the estate of his deceased wife, Felecia A. Graham of which he is the personal representative and trustee.

Mr. Graham has prospective sole voting power to vote the shares of Fisher Communications, Inc. in the amount of 285,828 shares held by a trust under the Will of Nellie Hughes Fisher and a trust under the Will of O.D. Fisher, which have nonattributable interests in Fisher Communications.

Mr. Graham is the father of Donald G. Graham, III.

**Donald G. Graham, III**

Donald G. Graham, III owns 14,400 shares of Fisher Communications, Inc. stock. In addition, he shares investment power as to 436,731 shares owned by the O.D. Fisher Investment Company.

**Phelps K. Fisher**

Phelps K. Fisher owns 84,960 shares of Fisher Communications, Inc. stock. Mr. Fisher is the Treasurer of the K. R. Fisher Investment Company, which has a nonattributable interest in Fisher Communications, Inc. K.R. Fisher Investment Company owns 134,872 shares of Fisher Communications, Inc. and Mr. Fisher has voting power over this stock.

Mr. Fisher has power of attorney for his two adult sons, one of whom owns 14,072 shares and the other owns 14,192 shares of Fisher Communications, Inc. and, as such, has voting power over this stock. Mr. Fisher's wife owns 11,000 shares.

In addition, he shares voting and investment power, as one of several trustees, as to the 326,388 shares of Fisher Communications, Inc. stock owned by the Lula Fisher Warren Trust and is an income beneficiary of such trust. In addition, he shares investment power with respect to 319,944 shares owned by the Warren Investment Company, of which he is a director. Mr. Warren is a first cousin of William W. Warren, Jr.

William W. Warren, Jr. owns 11,189 shares of Fisher Communications, Inc. stock jointly with his wife. In addition, he shares investment power with respect to 319,944 shares owned by the Warren Investment Company, of which he is a director. Mr. Warren is a first cousin of George Warren, Jr.
