Bank of America Corporation, NB Holdings Corporation and Bank of America, NA (100 South Tryon Street, Charlotte, NC 28225), as fiduciaries, possess shared voting and investment power as to 8.2% of the outstanding shares which interest is subject to the 20% attribution benchmark of Section 73.3555 Note 2(b). The bank has made no attempt to influence, directly or indirectly, the management or operation of the Applicant (or its parent), and none of the officers or directors of Applicant (or its parent) are representatives of the bank.
