Dear Educational Public Radio:

This minor change application requests a change in community of license from Layton, FL to Key Colony Beach, FL for WRTH. However, the exhibits provided are not sufficient for us to accept the application. Specifically, you must amend the application's "307(b) showing" (Section 307(b) of the Communications Act) to provide (1) a gain and loss study, and (2) a fair distribution analysis pursuant to Section 73.7002 of the Commission's rules.


A gain and loss study consists of: (1) the areas/persons which would gain new service and lose existing service if the proposal is adopted, (2) the number of reception services which are presently available within the gain and loss areas, and (3) whether the proposal would result in the creation of white (first aural reception service) and/or gray (second aural reception service) areas within the loss area or provide new coverage to white and/or gray areas within the gain areas.

Additionally, the amendment must include a fair distribution analysis in compliance with Section 73.7002. Toward this end, applicant must demonstrate whether or not the existing construction permit at Layton, FL or the proposed station at Key Colony Beach, FL could provide a 1st or 2nd NCE service to any number of persons.

Finally, please be aware that changes in community of license must be published in the Federal Register. Publication is done periodically; it has not yet occurred for this proposal. There is a 60 day holding period for such applications after the date of publication, to afford any interested parties an opportunity to file written comments on the proposal. This means the community change proposal cannot be granted before the second half of June at the very earliest. Keep in mind that the underlying construction permit expires by its own terms on September 15, 2011 and that the filing of this application does not warrant any extension of the construction period.

Further action will be withheld on this application for a period of 30 days from the date of this letter. Failure to provide the requested information within this time period will result in the dismissal of the application pursuant to Section 73.3566(a)(1) of the Commission's rules.
