Dear Applicant:

The above-captioned application for a minor change to a licensed facility construction permit proposes to change channels from 263L1 to 278L1. The *Second Report & Order* in MM Docket 99-25 established the definition of a "minor change" as it applies to LPFM applications.<sup>1</sup> The Commission stated that minor changes of LPFM stations may include changes of frequencies to adjacent of IF frequencies or, upon a technical showing of reduced interference, to any frequency. Therefore, the instant application specifying a non-adjacent channel change without a technical showing of reduced interference violates Section 73.870(a) of the Commission's Rules.<sup>2</sup>

Additionally, the application requests dismissal of two short spaced translator applications, BNPFT-20030317LKV and BNPFT-20030313AFY, on the basis that they will interfere with station WVEK-FM, BPH-20080219ALZ. However, those applications remain in pending status. Thus, LPFM applications must protect previously filed translator applications

In light of the above, application BPL-20080811AAY IS HEREBY DISMISSED. This action is taken pursuant to Section 0.283 of the Commission's Rules.<sup>3</sup>
