

**DESCRIPTION OF TRANSACTION, CHANGES IN INTERESTS AND  
PARTIES TO THE APPLICATION**

Because this assignment application is filed as part of an internal corporate reorganization, the proposed assignment is *pro forma* in nature. FCC Form 316 is appropriately used. Both the assignor, Gannett Georgia, L.P., and the assignee, Pacific and Southern Company, Inc. ("Assignee") are currently ultimately owned by the same parent entity, Gannett Co., Inc., as described below, and will continue to be after the proposed assignment.

Assignee is currently an FCC licensee of broadcast television stations WTSP-TV, Tampa/St. Petersburg, FL; WLTX-TV, Columbia, SC; WCSH-TV, Portland, ME; and WLBZ-TV, Bangor, ME, and Low Power TV station WGCI-LP, Skowhegan, ME and TV Translator W57AQ, Calais, ME.

Assignee is a Delaware corporation and is a wholly-owned subsidiary of Multimedia, Inc., a South Carolina corporation, which in turn is a wholly-owned subsidiary of Gannett Co., Inc., also a Delaware corporation and a publicly-traded corporation.
