## Non-Profit Corporation

CHRISTIAN MEDIA INCORPORATED

## THIRD

As an inter-denominational Christian organization: spread the Gospel of Jesus Christ with simplicity, clarity and imagination; strengthen the lives of Christians; and encourage Church attendance. Through Internet transmission and other means of communication to preach the gospel of Jesus Christ to the world.

This Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the Corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the Corporation shall not carry on activities not permitted to be carried on: (A) by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (B) by any organization, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Should this Corporation be disbanded, its funds and other assets shall first be used to meet all of its liabilities and financial obligations. Should any funds and other assets remain, the voting membership shall donate the funds and assets to an organization having a tax exemption under Section 501(c)(3) of the United States Tax Code or corresponding section of any future federal tax code. The voting membership shall retain sufficient funds to maintain the property and buildings of this Corporation until they are donated. Should the voting membership be unable to distribute the Corporation's funds and assets to a Section 501(c)(3) type organization, it may distribute the funds and assets to the Federal, state or local government for a public purpose. All assets not so disposed of shall be disposed of by a court of competent jurisdiction of the County in which the principle office of the organization is then located, to any organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code.
