PETITION FOR RECONSIDERATION

Central Educational Radio ("Central Educational"), by its attorney, hereby requests reconsideration of the cancellation of the permit for modification of FM translator K252EE. The facility authorized in the permit was timely constructed on October 30, 2015, long before the expiration of the permit. A license to cover was not filed previously due to inadvertence. The station uses a diplexed antenna together with Station K231BM, which also was authorized in BPFT-20150129AAA, and was also constructed on October 30, 2015. File No. BLFT-20151117ANW. The K252EE permit authorized a modification of the height of licensed station K252EE to allow for use of the diplexed antenna. Attached is an email establishing that the station modification for K252EE was implemented in 2015. Attached also is a photograph showing the diplexed antenna on the tower, and a Declaration stating that the diplexed antenna was installed on a timely basis 2015. A license to cover for the K252EE permit now has been filed.

WHEREFORE, based on the forgoing, it is respectfully requested that this Petition be granted; the permit be reinstated; and the application for license to cover the construction permit be granted.

I, Steven Fuchs, hereby state under penalty of perjury as follows:


I am President of Central Educational Radio, licensee of Station K252EE.

Station K252EE operates from a tower owned by me through Eagle Bluff Enterprises. In April 2015, Eagle Bluff purchased Station K231BM. An application for modification of K252EE (File No. BPFT-20150630ABG) thereafter was filed to allow for diplexing of Stations K252EE and K231BM on the tower. The application for modification of K252EE was granted on July 29, 2015.

The construction for both the permits for K252EE and K231BM were implemented on October 30, 2015. Although the application for license to cover the permit for K231BM was filed on November 17, 2015 (File No. BLFT-20151117ANW), the application for license to cover the K252EE inadvertently evidently was not file previously.

Attached is an email issued contemporaneously with the completion establishing that both the permits were built out and implemented simultaneously on a timely basis. Also attached is a photograph taken today showing the diplex antenna.
