THE SITE BEING PROPOSED CREATES A NEW SHORT SPACING WITH WHCY AND SLIGHTLY INCREASES THE FOUR OTHER SHORT SPACINGS.

EQUIVALENT 3 KW FACILITIES AT THIS HAAT PERMIT AN ERP OF 1.2 KW.
