

**Exhibit No. 1 - WHTC(AM) Holland, MI – Antenna and Ground System**

Vertical, guyed, series-excited, steel radiator of uniform cross section 57.91 m (100.84°) in height (60.4 m Overall) with a single bay FM translator antenna, and a 950 MHz STL antenna side mounted near the top, using isocouplers to cross the base insulator. Theoretical Efficiency: 313 mV/m/kW at 1 km; Restricted to 299.3 mV/m/kW at 1 km. Ground system consists of 120 equally spaced, buried, copper radials 60.96 m in length plus a 14.63 m x 14.63 m ground screen. The antenna input power is 920 Watts Day and Night per the WHTC(AM) BZ-20170309ABV License.
