

ASSIGNOR'S COMPREHENSIVE EXHIBIT

Description of the Transaction:

The instant application (the "314 Application") seeks consent for the assignment of the FCC license for commercial broadcast television station KFWD, Fort Worth, Texas (Facility ID No. 29015) (the "Station") from HIC Broadcast, Inc. ("HIC") to NRJ TV DFW License Co., LLC ("NRJ") pursuant to the purchase and sale agreement attached hereto ("Purchase and Sale Agreement").

As provided in the Purchase and Sale Agreement, contingent on approval of this application, NRJ will acquire substantially all of the assets of HIC. HIC, which is a family owned and operated business, is currently the subject of an FCC Form 315 application (File No. BTCCDT-20151007AFU) (the "315 Application"), which was accepted for filing on October 8, 2015 and placed on public notice on October 13, 2015. The 315 application seeks approval for the transfer of more than 50% of the common stock of the company from two of the three siblings who currently own the company, Enrique Hernandez, Jr. and Yvonne Hernandez Slaughter, to their mother, Bertha A. Hernandez, as Trustee of the Survivor's Trust Under Article VII of the Hernandez Family Trust, dated 12/21/1998, as amended (the "Survivor's Trust"). Consummation of the transaction proposed in this 314 Application for consent to assignment of the Station license is contingent on the approval and consummation of the 315 application. Accordingly, HIC provides responses to the items in this Section II of the 314 Application assuming that the pending 315 Application has been approved and consummated.

The Schedules and Exhibits to the Purchase Agreement contain proprietary information, and are not germane to the Commission's consideration of this application, or duplicate information already included in the application or in the possession of the Commission, and have been omitted. *See LUJ, Inc. and Long Nine, Inc.*, 17 FCC Red I6980 (2002). In light of these omissions, the Assignor and Assignee have responded "no" to Section II, Item 3(b) and Section III, Item 3(a). Copies of the documents will be provided to the Commission upon request, subject to the right of the parties to ask that the material submitted be held in confidence and not be made available for public inspection pursuant to applicable rules and policies of the Commission that restrict public access to confidential and proprietary information.
