

**TECHNICAL STATEMENT**  
**WCKT(FM) , FACILITY ID 35213**  
**CLEAR CHANNEL BROADCASTING LICENSES, INC.**  
**RADIO MULTIPLE OWNERSHIP ANALYSIS -- 08-28-2003**

This statement and the attached figures were prepared on behalf of Clear Channel Broadcasting Licenses, Inc. ("CCBL"), a wholly owned licensee subsidiary of Clear Channel Communications, Inc. CCBL proposes to modify the facilities of WCKT(FM).

WCKT(FM) is not located within any Arbitron metro but it is declared "home" to the Fort Myers, FL Arbitron metro. Accordingly, this statement is being provided to demonstrate compliance with the Commission's modified contour-based methodology for stations outside of Arbitron metros. The following radio stations are, or are proposed to be, under common control, time brokerage or joint sales by CCBL or its affiliates:

Attached hereto are lists of all commercial and non-commercial full-power radio stations that (1) have principal community contours (3.16 mV/m for FM, 5.0 mV/m for AM) that overlap or intersect the principal community contours of any of the above-listed commonly-controlled stations; and (2) whose transmitters are located within 92km of the area of mutually-overlapping principal community contours for the radio market in question.

WCKT(FM) is located in the Fort Myers, FL television Designated Market Area ("DMA"). The applicant hereby certifies that Clear Channel Communications, Inc. and its subsidiaries have no attributable interest in, nor have any joint sales agreement ("JSA") with, any television station licensed to the Fort Myers, FL DMA. Moreover, the applicant hereby certifies that Clear Channel Communications, Inc. and its subsidiaries have no attributable interest in any daily newspaper of general circulation published in the United States. Consequently, the new "cross-media limits" set forth in the Commission's Report and Order are not implicated by this application.

### **Radio Markets**

The "radio market" applicable to common ownership of the subject stations is defined as the area encompassed by the mutually overlapping principal community contours of the proposed commonly owned stations. These mutually overlapping contours form 5 "radio markets", as shown in *Figure 1*, for analysis under the Commission's rules.

Radio Market "1" is defined by the mutually overlapping principal community contours of WCKT(FM) (as proposed in the accompanying Form 301 application), WIKX(FM), WSRZ-FM LIC, WBCG(FM), WCCF(AM), WAMR(AM), and WKII(AM). The predicted principal community contours of these stations (4 FM, 3 AM) are shown in *Figure 2*.

Radio Market "1'" is defined by the mutually overlapping principal community contours of WCKT(FM) (as proposed in the accompanying Form 301 application), WIKX(FM), WSRZ-FM CP, WBCG(FM), WCCF(AM), WAMR(AM), and WKII(AM). The predicted principal community contours of these stations (4 FM, 3 AM) are shown in *Figure 4*.

Radio Market "2" is defined by the mutually overlapping principal community contours of WCKT(FM) (as proposed in the accompanying Form 301 application), WIKX(FM), WSRZ-FM LIC, WCVU(FM), WBCG(FM), WCCF(AM), and WKII(AM). The predicted principal community contours of these stations (5 FM, 2 AM) are shown in *Figure 6*.

Radio Market "2'" is defined by the mutually overlapping principal community contours of WCKT(FM) (as proposed in the accompanying Form 301 application), WIKX(FM), WCVU(FM), WBCG(FM), WCCF(AM), and WKII(AM). The predicted principal community contours of these stations (4 FM, 2 AM) are shown in *Figure 8*.

Radio Market "3" is defined by the mutually overlapping principal community contours of WCKT(FM) (as proposed in the accompanying Form 301 application), WIKX(FM), WCVU(FM), WOLZ(FM), WCCF(AM), and WKII(AM). The predicted principal community contours of these stations (4 FM, 2 AM) are shown in *Figure 10*.

Radio Market "4" is defined by the mutually overlapping principal community contours of WCKT(FM) (as proposed in the accompanying Form 301 application), WIKX(FM), WOLZ(FM), WCCF(AM), WAMR(AM) and WKII(AM). The predicted principal community contours of these stations (3 FM, 3 AM) are shown in *Figure 12*.

Radio Market "5" is defined by the mutually overlapping principal community contours of WCKT(FM) (as proposed in the accompanying Form 301 application), WIKX(FM), WDRR(FM), WBTT(FM), and WOLZ(FM). The predicted principal community contours of these stations (5 FM, 0 AM) are shown in *Figure 14*.

#### **Count of Stations in Defined Markets**

The number of radio stations in a "radio market" is determined by counting the market-defining commonly owned or controlled stations, plus operating full-power stations having principal community contours that overlap or intersect the principal community contours of the market-defining stations and whose transmitter is located within 92km of the area of market-defining mutual contour overlap.

In Radio Market "1" studied herein, there are 52 radio stations, including the subject co-owned stations, that overlap or intersect with the defined "radio market." *Figure 3* is the tabulation of the radio stations identified in the market.

In Radio Market "1'" studied herein, there are 50 radio stations, including the subject co-owned stations, that overlap or intersect with the defined "radio market." *Figure 5* is the tabulation of the radio stations identified in the market.

In Radio Market "2" studied herein, there are 49 radio stations, including the subject co-owned stations, that overlap or intersect with the defined "radio market." *Figure 7* is the tabulation of the radio stations identified in the market.

In Radio Market "2'" studied herein, there are 47 radio stations, including the subject co-owned stations, that overlap or intersect with the defined "radio market." *Figure 9* is the tabulation of the radio stations identified in the market.

In Radio Market "3" studied herein, there are 49 radio stations, including the subject co-owned stations, that overlap or intersect with the defined

"radio market." *Figure 11* is the tabulation of the radio stations identified in the market.

In Radio Market "4" studied herein, there are 48 radio stations, including the subject co-owned stations, that overlap or intersect with the defined "radio market." *Figure 13* is the tabulation of the radio stations identified in the market.

In Radio Market "5" studied herein, there are 52 radio stations, including the subject co-owned stations, that overlap or intersect with the defined "radio market." *Figure 15* is the tabulation of the radio stations identified in the market.

In the Fort Myers, FL Arbitron metro, there are 38 radio stations, including the commonly owned or controlled stations, of which there are 5 FM's and 2 AM's. *Figure 16* is the tabulation of the radio stations identified in the metro. Although this combination of commonly owned or controlled stations in the Arbitron metro is prohibited by the Commission's new rules, this application proposes no change in the location of WCKT(FM)'s community of license and, thus, the above combination is grandfathered and is considered compliant.

Only known licensed, operating full-power stations were included in this tabulation. Distances to contours for AM stations were predicted using the antenna patterns as identified in the Commission's AM database and the appropriate Ground Wave Field Strength versus Distance Graph of 47 C.F.R. § 73.184. Ground conductivities were obtained from FCC Figure M3. Distances to the FM contours were determined based on the method of 47 C.F.R. § 73.313. Terrain data was derived from the N.G.D.C. 30 second computer database for each of the FM stations using radials spaced every 45 degrees of azimuth.

Based on the above, it is concluded that this proposal complies with § 73.3555(a) of the FCC Rules.

Figure 01 - Market-Defining Principal Community Contours




Figure 02 - Radio Market "1" Principal Community Contours




Figure 03: Tabulation of Stations in Radio Market 1

Figure 04 - Radio Market "1" Principal Community Contours




Figure 05: Tabulation of Stations in Radio Market 1'




Figure 07: Tabulation of Stations in Radio Market 2




Figure 09: Tabulation of Stations in Radio Market 2'

Figure 10 - Radio Market "3" Principal Community Contours




Figure 11: Tabulation of Stations in Radio Market 3




Figure 13: Tabulation of Stations in Radio Market 4




Figure 15: Tabulation of Stations in Radio Market 5
