Dear Dr. Cruz:

The above-referenced station has been selected for an In-Depth Data Validation (IDV) of reimbursement requests submitted for payment from the TV Broadcaster Relocation Fund.¹ In order to determine whether the reimbursement requests submitted by the station on its FCC Form 2100, Schedule 399 were reasonably incurred, reimbursed to the third-party vendors as detailed in the station's submissions, and otherwise consistent with the rules and regulations governing this program, the station must provide written answers to the questions set out below, along with any supplementary documentation requested.

Furthermore, WIPR's response must include an affidavit or declaration under penalty of perjury, signed and dated by an authorized officer of the Puerto Rico Public Broadcasting Corporation with personal knowledge of the representations provided in the response. The affidavit or declaration must verify the truth and accuracy of the representations and information made in the response and must certify that all documents provided in the response are true and accurate copies of original documents. All such declarations provided must comply with Section 1.16 of the Commission's rules and be substantially in the form set forth therein.³

Failure to fully and timely respond to this letter may result in recovery of some or all of the reimbursement payments identified herein. To knowingly and willfully make any false statement or conceal any material fact in reply to this data validation may constitute a violation of the Communications Act and/or Federal Communications Commission rules and be subject to enforcement action.⁴
