Potential Attributable Interest Under EDP Rule. Riverside Broadcasting, Inc. ("Riverside") is the licensee of Station WIMX(FM), Gibsonburg, Ohio. CBL has supplied financing to Riverside in an amount which it believes exceeds 33% of Riverside's total capitalization calculated under the FCC's equity/debt plus ("EDP") standard. Cumulus holds FCC authorizations for other radio stations in the same market as WIMX, and, thus, the EDP attribution standard may apply to CBL's debt holding in Riverside.

CBL intends to assign its rights as creditor of Riverside to an independent third party and currently is taking steps to implement this plan as expeditiously as practicable. CBL anticipates that the assignment of its rights will be effectuated within the next few months. In the interim, and to the extent such a waiver is necessary, Cumulus will continue to request temporary waivers of the EDP rule with respect to CBL and WIMX until the proposed solution can be implemented.
