Dear Ms. Rodriguez:

This is in reference to the request filed on June 26, 2020. WBC requests a further extension of the STA granted on August 17, 2001, to continue operating using one of the existing WWFE towers to allow time to file the required FCC Form 302 application.¹ In support of the request, WBC stated that additional time will be needed to file the application before the permit expires on July 12, 2021.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Accordingly, the request for extension of the STA IS HEREBY GRANTED, and WBC

may continue to operate using the existing WWFE tower (ASRN #1215856) with a maximum of 1.8 kW (day)/0.125 kW (night). WBC must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR §1.1310. WBC must submit an e-mail to my attention to note the date the application was filed before the construction permit expires on the date shown below.

This authority expires on **July 12, 2021**.
