Ownership Study

This technical report is provided as an analysis of the aural broadcast markets formed by the modification of the KLQQ, at Clearmont, WY, from 284C3 to 285C0.

The Applicant has an attributable ownership interest in the following stations:

Commonly Owned Stations:

1. KLQQ(FM)	285C0	Clearmont, WY
2. KROE(AM)	930 kHz/ 5 kW	Sheridan, WY
3. KWYO(AM)	1410 kHz/ 5kW	Sheridan, WY
4. KYTI(FM)	229C	Sheridan, WY
5. KZWY(FM)	235C	Sheridan, WY

None of the stations are located within an Arbitron Metro area; as a consequence, the permitted common ownership is determined using the contour-overlap methodology. The exhibits include the city grade contours, 3.16 mV/m (FM) and 5 mV/m (AM), of all stations intersecting any of the mutually overlapping stations, including full service noncommercial, and exclude any stations with a transmitter site greater than 92 km from any portion of the mutually overlapping area, as well as any non-overlapping commonly owned stations.

Mutual overlap of the commonly owned stations forms a single market, which contains a total of fourteen stations. Exhibit E-1 shows a reference plot of all commonly owned stations, and exhibits E-2 and E-3 show the market plot and list of the defined market, respectively.

Following the rules provided by CFR §73.3555(a)(1)(iv), the common ownership of three FM and two AM stations in the defined market is permissible.






E-1 KLQQ Reference Plot - All Commonly Owned Stations


